# The End of Cultural Relativism

About a decade ago, a foundation sponsored by the Savings Banks of Sicily published a small book on *Dante's Ideas on Credit and Monetary Policy*. The book assembled the evidence of a major economic breakdown crisis in Dante's time, and demonstrated that Italy's great poet was a fiery opponent of those policies known today as *monetarism*. The author of the book pointed out that the very same evil policies which Dante and other leading thinkers fought to eradicate on the eve of the Renaissance have been revived today under the aegis of the City of London banks and their political errand boys.

Departing from academic protocol, the Italian professor who wrote the book proposed that Dante's surprisingly specific attacks on Guelph-papal ploys to loot the natural resources, labor power, and productive capacities of Western Europe should be revived today to trounce Guelphish proposals such as the London campaign for a "Europa" currency to be floated on the sole basis of speculative hot air.

Thus was Dante Alighieri, at the venerable age of 700, recruited to the ranks of the faction in the advanced capitalist sector which wants industrial development, utilizing a sound, gold-backed currency to finance hard-commodity trade and high-technology development.

We welcome the author of the *Divine Comedy* to the ranks of humanism's warriors for the new world economic order, and propose taking the correlation much further than the self-limiting scope of the Sicilian Savings Banks. Contrary to the pundits who would have us believe that he was a great genius "looking backwards to the Middle Ages," Dante Alighieri was among the initiators of the conspiracy which brought industrial capitalism into being out of medieval mercantile capitalism. Not only did he clearly identify and detest the usurers, simoniacs, and other "monetarists" of his day. He framed a statement of political and cultural program in opposition to monetarism which is still of extraordinary power. His particular target was the localist ideologies which the Guelphpapal cabal manipulated, under the banners of "citystate liberty," to prevent consolidation of an effective opposition and the emergence of a peaceful political order in which the cities would flourish. In the first decade of the fourteenth century, Dante demolished all basis for what passes today as "cultural relativism."

"Cultural relativism," shamelessly appropriating the word "relativism" from its use in physics, is merely bestialism — the policy of denying a population its necessity to develop through technological progress on the grounds that the culture it already happens to have is genetically suited for it. To enforce a lower, entropic level of culture upon a population to make it the more susceptible to monetarist looting, the intellectual mercenaries of the London and New York banks reinforce their victims' attachment to the narrow world of tribe, local community, and "mother tongue." Thus the victim is deprived of the material and cultural enrichment necessary to make creative contributions to humanity as a whole, and, ironically, deprived of whatever human content his culture may possess as the potential for change and development.

The suburban-spawned "cultural relativist" who rejects nuclear fission and fusion energy for the Third World, on the grounds that Western technologies will spoil the unpolluted "quality of life" in a remote tribal haven below the Tropic of Cancer, is propounding a doctrine which has exactly the same significance as the terrorist's bomb or the imperialist bayonet.

Nor should anyone pretend to be taken in by a Margaret Mead's indecent prattling about "preserving cultural diversity" against technological progress. A rich diversity of culture in the product of humanism. A society which is growing and expanding requires a constant increase in the numbers and varieties of gifted individuals it produces. The successful application of any given mode of technology leads to the exhaustion of the relatively fixed resources of that technology. Human survival demands new inventions by creative individuals and the assimilation of these inventions by the wider population, so that previously marginal resources may be opened up.

It is against that *humanist* diversity of culture that cultural relativism is most viciously deployed in times of economic breakdown by the monetarists. At its most extreme, cultural relativism — the instrument of colonial rule which William Pitt the Younger used to prevent the example of the American revolutionary patriots from spreading to other British possessions is now being returned to American college campuses and high schools through the mass importation of such British excretions as punk rock and legalized "recreational" drugs.

#### Dante Versus Monetarism

Dante in his greatest work, the Divine Comedy, warned that disaster would overtake Europe if certain practices of the Guelph bankers continued. The gentlemen he had in mind, dominated by the Florentine Bardi, Peruzzi, and Accaiuoli families, took great care to preserve the face value of their gold florin, which was used for their lucrative international exchange dealings in which usurious rates of hidden interest were concealed. However, and this is the policy singled out for the poet's censure, they met the inflationary consequences of this international financial policy by systematically clipping the *local* silver coinage, which was used to compensate labor and restore the conditions of production.

Certain contemporary "free enterprisers" who propose to restore the United States'dollar's stability by slashing imports, declaring a trade war on this nation's industrial trading partners, and depressing workers' consumption would do well to examine the outcome of such economic cannibalism in the first half of the fourteenth century. The triumph of the aptly named "Black" Guelph party in Florence in 1302 and the exile of the city-state's leading statesman Dante Alighieri marked the onset of a half-century of worsening plagues, wars, and tyrannical governments. The countryside was ravaged and peasants were herded into the slums of Florence for sweatshop labor under conditions which did not permit them to reproduce themselves in another generation. The citizen militia collapsed and gave way to an "all-volunteer" mercenary army. Following the 1342 Bardi-Peruzzi bankruptcies, all of Europe was swept by the Black Death in 1348. Half the population perished.

It was against this bestial Guelph culture, which proceeded in disregard of the lessons of the past and the potentials of the future, that Dante framed the new world economic order of *De Monarchia* and fashioned his magnificent *Comedy* in vernacular Italian poetry as the political rallying-point of an Italian humanist republic. The theoretical basis for his cultural policy he set forth in one of his great Latin essays, *De Vulgari Eloquentia* (On the Eloquence of the Vernacular Language).

Although left uncompleted (probably between flights from one political refuge to another in the early years of Dante's cruel exile), the pedagogy and intent of De Vulgari Eloquentia is unmistakable. Hence it is ludicrous to portray this treatise — as in college literature books - as an argument for elevating Tuscan dialect to be the national language of Italy. Instead, De Vulgari Eloquentia presents the necessity of a national culture from precisely the same standpoint from which, on another occasion, he argued for the necessity of a supreme world secular order in *De* Monarchia. As he constantly suggests through his use of metaphor and analogy, for Dante the physical universe and human political and cultural activity operate by the same universal laws - the standpoint of hylozoic monism.

Dante begins by identifying the distinctively human quality of speech. Only man — not the beasts — must communicate his passions and actions to others, so as to further the process of social development. He proceeds to lead the reader through a succession of more advanced states of consciousness of his own speech, from the "mother tongue" to a historical grasp of the evolving identity of language's origins and destiny. Beginning with the Tuscan language, Dante takes the opportunity to distinguish between his own love, as a "citizen of the world," for his native Florence and its surrounding Tuscany region, and that of the childish belltower chauvinists, including those who exiled him.

After weighing and dismissing the merits of each municipal dialect to qualify as a national language, Dante proposes that a rational standard must be found, just as in physics, against which the particular may be defined.

Wherefore in our actions, however many the species into which they are divided may be, we have to discover this standard by which they may be measured. Now the supreme standards of those activities which are generically Italian are not peculiar to any one town in Italy, but are common to all; and among these can now be discerned that vernacular language which we were hunting for above, whose fragrance is in every town, but whose lair is in none.

#### The quarry is now cornered:

... Having therefore found what we were searching for, we declare the illustrious, car-

dinal, courtly and curial vernacular language in Italy to be that which belongs to all the towns in Italy but does not appear to belong to any one of them, and by which all the municipal dialects of the Italian are measured, weighed, and compared.

Dante's little joke, of course, is that the "beast" is not the language at all, but the reader's mind, caught in sudden possession of its self-conscious rational faculties. By "courtly and curial" Dante has singled out the *historical* language of the peninsula's secular institutions, namely the court and universities of the Hohenstaufen emperors who had fostered poetry in the still-crude vernacular tongue as crucial to organizing for their political program of urban development in the century before Dante's birth.

The poet's pedagogy, superseding a bestial emotion with the joy of discovery of the universal aspects of one's own speech, implies a true (not "cultural"!) relativism, as the Labor Committees' founder Lyndon H. LaRouche, Jr. has interpreted that notion in Riemannian relativistic physics with the aid of Cantor's transfinite. The characteristic feature of a Riemannian continuum is the causal principle which governs the ordered transformation from a continuum of one specific relativistic "geometry" to another of higher order in terms of negentropy, that is, in terms of the rate of increase in energy throughput of the entire system. This defines a universe in which the causal principle of ordered transformation to a higher "geometry" determines the ordering within each specific geometry.

Only at the current phase of man's mastery of the physical universe are we at the threshold of empirically verifying, in the frontiers of plasma physics, that the laws of the universe do change in this ordered succession. However, Dante knew that this process was true of the human mind, and his rigorous commitment to a monist world-outlook impelled him to constantly pose the irony of an apparently fixed, medieval cosmology against the self-developing intellectual potentiality of the human species as a whole which is his fundamental premise.

When he wrote his call for a national cultural effort, embodied in a national language, for a country which had yet to become politically a nation, Dante was not undertaking an abstract exercise in literary niceties. In 1302, in a brazen "linguistician's" trick which would make Noam Chomsky envious, the Black Guelph party took advantage of Dante's absence on a diplomatic mission to trump up charges against him of "barratry" — the crime of misappropriation of public funds. Had Dante returned to Florence for trial,

he would have been boiled alive in oil, the punishment for barratry. The charges stemmed from the fact that as holder of the highest civic office of prior in 1300, Dante committed public funds to the militia to defend the city from invading papal and French troops! The invaders had been brought there to impose upon Florence the rule of the "Black" Guelphs who had been politically defeated by the antipapal "White" Guelphs, the circle to which Dante belonged.

Readers of the *Divine Comedy* will recall that Dante not only excoriated the evil Blacks who convicted him *in absentia*, but mercilessly pilloried the sheepish majority of Whites who lacked the strategic conceptions and philosophical cohesion to fight the monetarist conspiracy. He embarked upon the project of reviewing Western European and Florentine history from the fresh standpoint of the struggles in his day. He became a Ghibelline — the party of the secular monarchy of the German Empire, which had been pitted historically against the papacy and its feudal landholding financiers.

Dante's tribute to the "eloquence of the vernacular" is an integral part of this project to restore and celebrate the Hohenstaufen tradition which had been slandered and obscured following the death of Frederick II's last surviving son and the definitive triumph of the Guelphs in 1267. Frederick, a century before Dante wrote, had established a great center of translation and recovery of Greek and Arab science in Naples, to form the leadership cadres for his Empire and as an intellectual counterpole to the papal "think tank" of the University of Bologna.

The papacy centered its curriculum around the "linguistics" of the Middle Ages, canon law - a school of legal forgery whose most famous production was the "Donation of Constantine" in which the Roman Emperor "willed" his temporal power to the pope, thus legitimizing the looting operations, through papal taxation, of the Roman feudal aristocracy. Frederick not only banned canon law from his university in Naples, but made his court the center of a project to enrich the vernacular tongues so that the population of his empire could assimilate the advanced concepts being recovered through translation. Dante harkened back to this tradition in order to give Italy's skilled artisans, intellectuals, and humanist princes the sense of their own antecedents that they needed to build a nation from the shambles of the Guelph collapse.

The monetarists have never forgiven Dante for his insights and the power with which he carried them to fruition, and have settled the score by lying that Dante was a "medieval visionary." Dante, who in 1301 was selected to head Florence's largest urban develop-

ment project, is described as antagonistic to the growth of the towns and their commercial development, and out of touch with the trends of his time. As proof of this thesis, it is actually maintained by many historians that the anarchism and egotism of the Black Guelphs is the real antecedent to the noted "individualism" of the fifteenth century Renaissance!

#### **History's History**

From a keen sense of the necessity to arm today's humanist faction with the truth about its history in the face of the current world depression, the Labor Committees have undertaken, over the past two years particularly, the project of reviewing the past 4,000 years of recorded history. The battle between monetarism and humanism which raged fiercely in Dante's epoch and in our own goes back, in the form of two conspiratorial tendencies, to our earliest recorded predecessors — indeed, in all likelihood, to earliest man.

The process of uncovering history as the consequence of man's willful intervention into nature through such "networks" has led to a secondary but extremely important discovery about history itself a discovery which gains in importance with the sheer weight of the written record. While history is not "bunk," *pace* Henry Ford, a great deal of bunk is passed off as history. Consequently, the real dynamic of historiography has always been that of a politicalintelligence faction of humanists working in opposition to a band of plagiarists, counterfeiters, and professional forgers.

The recent admitted forgery of the supposed epic of African-Americans' heritage, *Roots*, by a collaborator of Anglo-American monetarists' intelligence networks, is only one of the more obvious frauds perpetrated in the service of monetarism. The object of this particularly crass operation was to convince black Americans they do not rightfully inherit the achievements of American humanism and its European antecedents, but instead must look back to a history of slavery and oppression and find themselves in their great-grandmother in an impoverished African village. The same can be said for the peddling of the slavetraders' language, Swahili, to black college students at the City University of New York.

More far-reaching and of somewhat more sophisticated manufacture are the two ideological edifices which this issue of *The Campaigner* undertakes to raze. One is the shibboleth of "Jewish exclusivism," and Israel's "biblical rights" to certain Middle East soil, an ideology assiduously cultivated over the past 200 years by the British Empire's intelligence services, including a large investment in "archeology" in the Middle East, to provide continuous inputs of new carefully edited. "evidence" on the antiquity of the biblical Jews. The second is Karl Marx's ingenuous acceptance of the twin myths of British liberal capitalism and French Jacobinism, which were massively propagandized by the British victors after the 1815 Concert of Europe, while the influence of the American Revolution and of Benjamin Franklin's European humanist networks was systematically hushed up.

We do not particularly relish flushing out the Augean Stables of the liberal arts faculties. However, the effort to reestablish the history of humanism forces us to undertake that task. In the case of Karl Marx, the opening chapter by Lyndon H. LaRouche, Jr., of a forthcoming book on Marx's real biography, which we print here, grew out of an intercontinental intellectual effort to discover Benjamin Franklin's sources and influence. As that influence assumed its true colossal historical scale, the more glaring became the anomaly that Marx was oblivious that Alexander Hamilton had anticipated his notion of labor power. LaRouche has related this to two other observations about imarx's historical "blind spots" -Marx's acceptance of the "originality" of Adam Smith, David Ricardo, et al.; and his rejection of his American correspondent, the economist Henry Carey's, notion of a "community of interest" of labor and industry for industrial progress. In turn, these blind spots with respect to history pointed towards the reason for the otherwise nearly inexplicable question of why Marx abandoned the monist methodology he had so clearly set forth elsewhere (The German Ideology, etc.) in his abysmal efforts to explain expanded reproduction mathematically in the unfinished final chapter of the second volume of Capital.

An analogous process led to Paul Arnest's article in this issue, "From Babylon to Jerusalem." The original impetus for this article was provided by recently publicized archeological discoveries in the Middle East which raised anew the question of the common roots of Jews and Arabs. The accumulated "biblical archeology" was compared with ongoing work by Arnest and others on the accomplishments of the ancient Phoenicians and Ionians. The abyss which yawns between both the Neoplatonic aspects of modern Judaism, and the actual high-points of the ancient peoples of Israel and Judah (under King David and Solomon, for instance) on the one hand and the monotous incantation of retributive tribal laws on the other, in the first five books of the Old Testament — forced a closer examination of historical evidence which took editor Arnest right back to the scribes of Babylon. What emerged from the critique is that the Babylonian rulers, in order to keep the Jewish people docile, paid or otherwise compensated a string of Elijahs and Jeremiahs, Ezras and Ezekiels to preach zero-growth, chauvinistic policies ("cultural relativism" and its twin, "environmentalism"). On balance it was not very different from the way the Kaplan and Stern Foundations or the Rockefeller Brothers Fund maintain Ralph Nader and Cesar Chavez today — for the same purposes.

It so happens that the puncturing of these two historical fabrications and the replacement of the lies by an actual, if preliminary, account of the "monetarist" and "humanist" factions at work, is crucial to the potential for world peace and a new world economic order today. Not only are the Bible and Marx's Capital all-time world best-sellers. More importantly, whole populations and large international factions in today's world which play a crucial strategic role — notably the population of Israel and American Jewry, as well as the Arabs; and the Soviet and Eastern European ruling communist parties, as well as their western counterparts - currently share the delusions about their own history which are exposed in this journal. These delusions contribute to paralyzing potential humanists, or at least factions which would operate in the interest of the survival and prosperity of their populations. Once the initial shock has been absorbed and the cold shower is over, the assimilated contents of this Campaigner will help to make it possible for Jews and Arabs, capitalists and socialists to sit down at the negotiating table for a new -international monetary system and work out a global program of economic development utilizing fission and fusion technologies.

#### The Criteria of Culture

We specify nuclear power because it provides the immediate clue to the rational criteria by which we may judge what is of value in culture today. Late in 1977, the acknowledged leaders of the international physics community put out, from a University of Miami meeting, a strong call for nuclear fission and fusion development as the only alternative to global ecological holocaust and war. This seconds what the Labor Committees have been saying for some time.

Fission and fusion technologies uniquely afford the energy density — the rate of energy produced per energy expended — to mediate a leap into a higher global political economic "geometry." None of the

alternatives which have been proposed for solving the energy crisis even comes close. Without the promise of nuclear energy in the short term ahead, and the rapid exhaustion of existing fossil fuels on that basis, hundreds of millions of human beings will be condemned to the cultural relativist's nirvana of starvation, plague, or thermonuclear annihilation.

But, provided the London-centered monetarists are deprived of political power through a freeze on financial debt holdings, credit may be redeployed through a new central banking institution into nuclear energy-based global economic development. Under those conditions, we can look forward to the greatest epoch of industrial prosperity the world has seen. This includes, emphatically, the necessity for that overwhelming proportion of the world's population hitherto condemned to bestial manual labor, to be educated to make productive contributions as the skilled workers, engineers, and scientists of the future.

When Dante's heirs, the humanists of the European Conciliar Movement of the late fourteenth-early fifteenth century, set out to rebuild an urban culture from the ravages of the Bardi-Peruzzi bankruptcies, they used analogous criteria. Against the nominalist "cultural relativists" of their day, they deliberately revived Dante and his humanist cothinkers from earlier in the century, for the notion of the positive role of secular government in fulfilling the aim of raising the "intellectual potential" of the entire human species. For the first time they gave this general goal its specific content of urban-based technological progress.

The Conciliar Movement was a political movement to bring the Church under the control of a secular humanist world-order, as it had been espoused by Dante and Dante's younger contemporary, Marsilius of Padua, the Ghibelline author of The Defender of the Peace. Before the Black Death Marsilius had evidently formed a political cadre-leadership in France and Germany around a notion of secular government for the benefit of humanity as a whole, which amplified the ideas set forth by Dante in De Monarchia. In the second half of the fourteenth century, following the Black Death, a depopulated Europe was sacked over and over by armed bands of freelance mercenaries, many of them led by condottieri who began their careers in the English army of the Hundred Years' War, and then continued as professional looters because they had no more home to return to. It was in this situation that Dante's ideas of a political order which would guarantee peace and thus foster scientific development took the shape of the drive to reform the Church, through the convening of a council of the national churches of the great European "nations."

To the Conciliarists we owe the crucial notion of the "inventor," the gifted individual whose creative innovations mediate qualitative advances in technology; and we also owe them the innovation of critical historiography, for expurgating history of monetarist frauds. Around these two interrelated efforts they organized the political movement for a new world economic order which we know as the Renaissance. In broader terms, they conspired to bring into being industrial capitalism.

The humanists of that period, like the humanist faction today, had to deal with bestialists on both the "right" and "left" wings of the political spectrum. On the right there was the direct police-state rule of the Dominican order, "God's dogs" of the papacy, whose outcry for a return to the bestial austerity of the preurban Middle Ages was heard everywhere in Europe after the Black Death. On the "left," the antipapal camp was shot through and through with proausterity anarchists who functioned as de facto, although not always conscious, agents of the papacy and its doctrine of papal infallibility. Such, for example, was William of Ockham, the English Franciscan friar who was driven into the antipapal camp by the Dominican vendetta against the rival begging order.

Ockham fully agreed with the Dominicans that the laws of the universe are essentially fixed, and that no secular government can serve the higher, distinctively human aspirations of the individual soul precisely the function which Dante had assigned by necessity to a world secular government. By relegating to the empire only punishing functions and by placing individual "freedom" on a purely negative, anarchic basis that freedom stops where one's neighbor's freedom is impinged upon, Ockham effectively handed the keys to the earthly kingdom right back to the pope and his Guelph-Dominican allies. "Cultural Relativism" was epitomized in the Ockhamite following by the Paris nominalist Jean Buridan, who foreshadowed today's drug-befogged advocate of "gay lifestyles" with the formulation of "freedom of indifference," known as Buridan's Ass. This is illustrated in the parable of the hungry and thirsty jackass, who, placed midway between a bale of hay and a bucket of water, dies because it is unable to choose between the two!

It is important to chronicle, although summarily, the process by which the humanist faction turned Buridan's Ass into an object of ridicule for the next 200 years, and simultaneously brought into being the direct antecedents to the modern "American System" of industrial progress. When the Council of Florence met to decide the fate of the papacy in 1440, its protagonists were confronted with a twofold *fait accompli* which sensuously demonstrated the reality of progress in man's conquest of the physical universe, and showed that the humanistic studies so assiduously undertaken from the late 1300s onward in Europe were capable of debunking the entire false structure of the papacy's canon law. Together, these achievements destroyed the authority of feudal banking based on ground rent, which had kept the political economy of Europe in a straitjacket.

We refer to two very specific accomplishments. On the one side, there was the magnificent dome of Florence cathedral, completed in less than two decades according to the 1418 project of Filippo Brunelleschi, despite a barrage of criticism and attempted sabotage by the Ockhamites, not dissimilar to today's "environmentalist" assault on nuclear energy. The dome demonstrated & conceptual solution, based on applying the most advanced available ideas in abstract mathematics, to an otherwise insoluble practical problem, that of spanning a forty-meter space without using costly "centering." More generally, Brunelleschi showed how a "modular" technology could displace the fixed laws of medieval building practice to multiply labor power through engineering ingenuity, and thus paved the way for the breakthroughs in movable-type printing a decade later and in navigation of the global oceans. Brunelleschi's solution, and the related advances in geography and astronomy which he and his collaborators were working on at the center of a scientific network which stretched from Portugal to Oxford to Constantinople, were analogous in their long-range implications to the international scientific collaboration for nuclear energy today, particularly the fusion effort.

Brunelleschi's methods made it possible to fulfill the Conciliarists' commitment to the building of new cities as the locus for new republics, which they saw explicitly as political formations where the realization of the mental capacities of the largest possible number of individual citizens in serving the commonwealth would prevent the devastating ravages of disease and war. By ruthlessly suppressing (no cultural relativist, he!) the medieval stonemason's stone-by-stone approach to the project and creating a standardized vocabulary of architectural elements, Brunelleschi accomplished a revolution in architecture. For the first time it was possible to construct an entire new city according to a plan, within the lifetime of a generation. The fixed limits of the medieval cathedral, which for political as well as technical reasons took many lifetimes and even centuries to

build, were surpassed with a stride as powerful as man's twentieth century steps to conquer the solar system for his habitation.

The other achievement shows that such scientific advances were not attained without a fierce political battle. In 1440, the Italian humanist Lorenzo Valla used the philological tools which had been developed throughout the preceding period to prove conclusively that the Donation of Constantine was a fraud. In terms of overall political impact, in freeing Western Christians from the traditions of the feudal papacy and enabling them to weave the basis for an entirely new political world-order based on the Neoplatonic core common to Latin and Greek Christendom, Judaism, and Islam, this exposé by Valla was on a par with the Labor Committees' current historical work in dismantling the fraud of the "left" versus "right" categories of political science. Thus, it is hardly a coincidence that Valla published his shattering proof at exactly the same time that Cardinal Nicholas of Cusa, the master theoretician and diplomat of the Conciliar Movement, successfully brought to Florence the leading representatives of the Greek Empire and Greek Orthodox Church, long in bitter conflict with the Latin West. It was also the great German Cardinal of Cusa who in those same years was studying the Koran to determine what community of interest could be established between Christianity and Islam.

Looking forward from those events of 1440, what unfolds is the series of breakthroughs which we associate with modern science and industrial development. In Florence itself, on the basis of the informal meetings occurring around the 1440 Council proceedings, the Platonic Academy of Ficino was founded not long after 1450. This institution in turn became the seed-crystal for schools and publications from Tudor England to Muscovy which were set up outside the "liberal arts" establishments as centers of Neoplatonic epistemology and the applied sciences — including a strong emphasis on language enrichment.

This was an "American" faction in a quite specific sense. Both Christopher Columbus and Amerigo Vespucci, the latter a Florentine educated in Ficino's circle, took the theoretical basis for their voyages west across the Atlantic from the geographical studies which were part of the Conciliarists' curriculum. In slightly more long-range terms, the Neoplatonic networks descending from Cusanus, Ficino, and Brunelleschi were also — as early as the sixteenth century — the initiators of the idea of a humanist republic in the new world which would revitalize Europe politically, and thus the precursors of the American Revolution.

If we look back from 1440, to the early years of the Conciliarist struggle, we find that Dante Alighieri was matriculated early along in the "American" faction. The first sign of Dante's deployment against the nominalist "cultural relativists" came fifty years after his death, in the decade of the 1370s. During the early 1370s, the Florentine Republic instituted an official "Dante lectureship" in the Cathedral, and in this way declared to the world that the poet's native city was turning its back on the political system which had led to the poet's exile. That such an act would have Europeanwide impact is confirmed by the fact that among its chief instigators was the city's chancellor Coluccio Salutati, and that Salutati was in constant correspondence with the northern European initiators of the Conciliar Movement, such as Cardinal Pierre D'Ailly and other figures linked to the Brotherhood of the Common Life in France and the Low Countries. The political intent was further confirmed when shortly after this, also in the 1370s, the City of Florence declared war on the papacy. As a result of this war and the subsequent uprising in the city known as the Ciompi Rebellion, the Guelph Party was defeated and reduced to a mere status symbol in Florence, its stronghold since the lifetime of Dante.

The anti-Guelph political movement in Florence, which in certain respects became the focus for similar efforts throughout the West, set the context for another extraordinary event of the 1370s. The Building Committee of the Cathedral of Florence, which included Brunelleschi's father, decided upon the final ground plan for the church, under construction since 1296. The 1370s ground plan provided for a dome larger, by far, than existing manpower and building materials could possibly have constructed by existing methods.


The hubris of the Florentine Building Committee, confident that a genuis would be produced in their midst to solve the problem (Brunelleschi the Younger was born in 1377), evokes the correct approach to today's world energy crisis - exactly the opposite of the abortion proposed by the zero-growth "conservationists." The only way in which the world's living standards can be raised sufficiently rapidly to prepare for a fusion economy, and begin to create the quality and quantity of labor power which fusion will require, is to begin at once to rapidly deplete the relatively fixed supplies of fossil fuels for crash, high-energy economic development — while fission reactors and fusion power plants are being brought on line. Like the Florence city fathers, who made their decision to build the dome while they were at war with the feudal papacy, we have solid reasons to be confident that the

remaining technical and scientific problems of fusion can be solved in time — provided the political commitment is unflinchingly made.

The "Dantesque" faction won their battle for progress in the fifteenth century, for the same reason that the humanists must win in the twentieth. History illustrates that the essence of a human being, as distinct from a beast, is his ability to supersede each successive crisis through applying the powers of creative mentation. Dante stressed that these powers can only be applied *socially*. In plasma physics research related to fusion development, we are on the verge of demonstrating that the law of the human mind is the law of the universe — that man's willful activity can change physical laws. The cultural relativist may not know whether to choose a bale of hay or a bucket of water. We, however, have an exciting future to build, and necessity beckons us.

In the process, it is only proper that we recall with pride the debt we owe "to those who have gone before."

# THE KARL MARX KARL MARX DID NOT KNOW

"When we have chosen the position in which we can most work for mankind, then burdens cannot bow us down, because they are only sacrifices for all; then we enjoy no poor, narrow, selfish joy, but our happiness belongs to millions, our deeds live quietly, but forever at work, and our ashes will be moistened by the shining tears of noble men."

-Karl Marx, Aufsatz, 1835

Like most citizens today, Karl Marx was ignorant of the most crucial facts of the eighteenth and early nineteenth centuries' closely intertwined European and American history. That ignorance of the very traditions which directly formed his lifelong world outlook during his youth compels us to judge Karl Marx as first among those many other scholars of "the young Marx" who, to this date, are still occupied with their own efforts to discover the real origins of his outlook and method.

More than a matter of scholarly curiosity is at issue on this point. Exemplary is the fact that had Marx not been ignorant of his own political roots, especially of the powerful indirect influence of the American Revolution on his childhood development, he could not have committed the fundamental historical errors which flawed his adult work on history and political economy.

During the late eighteenth century, and continuing into the nineteenth century, all of the key urban centers of the Rhineland, parts of southern Germany, and centers such as Weimar, were dominated by the influence of the American Benjamin Franklin and Franklin's Illuminati and Freemason collaborators. Cologne, Bonn, Coblenz, Mainz, and Marx's own home city Trier were hotbeds of the same general tendencies of humanist republicanism represented by Franklin, Tom Paine, Turgot, Condorcet, Lavoisier, and Priestley. The influential Herder, who played a leading role in the effort to spread Franklin's ideas and writings throughout Germany, exemplifies the common active links of Franklin's included influence among such figures as Beethoven's childhood teacher Neefe and Schiller and Mozart.

Marx himself was most strongly influenced by these humanist currents. The director of the gymnasium at which the young Marx studied during the period 1830-1835 was one Johann Hugo Wyttenbach who, although otherwise predominantly a Kantian, professed Benjamin Franklin as the strongest influence on his thought. The literary and political society, the Kasinogesellschaft, of which Marx's father and future father-in-law were members, was a hotbed of "German Saint-Simonism" and anti-Prussianism and also fervently anti-Napoleonic. To one who knows the epistemological characteristics of the humanists around Franklin's leadership, a reading of Marx's 1835 Aufsatz for school director Wyttenbach leaves no

Admittedly, some researchers are confused by the near-simultaneity of anti-Prussian and pro-Prussian views among Marx's father and associates. Their confusion on this point arises because they lack perception of the way in which German humanists understood (somewhat correctly) the highlights of the French Revolution. Contrary to modern mythology, which dates the "right turn" of the French Revolution to the Ninth of Thermidor, the German humanists, like the American Federalists, had seen many of their leading cothinkers sent to the guillotine by British agents-demagogues Danton and Marat, and viewed Napoleon (rightly) as so much a reactionary that the German republicans, being otherwise devoutly anti-Prussian, followed Gneisenau and Scharnhorst willingly and vigorously into an alliance with Prussia against the "greater evil."

Marx's own ignorance respecting his immediate predecessors' history was neither astonishing nor by any means exceptional for his or later times.

The great upsurge of Franklin's influence in Europe was quite literally chopped off with the guillotining of Lavoisier and the death of Condorcet. By the end of the second decade of the nineteenth century, the events of the Jacobin Terror and the subsequent obscenities of Napoleon had wiped out the humanist movement as an organized force. Saint-Simon's fevered efforts to revive the influence of the American Federalists in Europe was but a faint echo of the great, latershattered humanist movement of which Saint-Simon and his father had been a part.

G.W.F. Hegel, himself a product of the preceding south German humanist ferment of the eighteenth century, typifies the tendency unloosed among German humanist leaders by Napoleon's disgusting compromise with the Hapsburgs and his anointing himself Emperor. Like the humanist Illuminati and republican Scharnhorst, Hegel allied his forces with Prussia against Napoleon, and, to that extent, indirectly made peace with the great enemy of all humanism, the English house of Guelph. Beethoven's instinct is shown in his efforts at composing a symphony celebrating Wellington's victory, a travesty all Beethoven's admirers are happier to forget. Beethoven's soul was not in it.

Into the circumstances following the Treaty of Vienna emerged the historical fraud composed by Madame de Staël, and the embellishment of the same fraud by the scurrilous Lamartine. All modern histories of the French Revolution in general use, including those so-called historians admired by the despicable French Communist Party leadership, faithfully follow in the pattern set by the frauds of de Staël and Lamartine, the myth of the Ninth of Thermidor. Madame de Staël was otherwise the daughter of Louis XVI's last finance minister, Swiss bankers' agent Necker. It was Necker who sabotaged the French economy by undoing the work of Vergennes and Turgot, and who, in the service of the foreign bankers and the worse aristocrats, shaped the monstrous financial crisis which unleashed the French Revolution. At one point, underlining Necker's real sympathies, his daughter was projected to marry William Pitt the Younger. Madame de Staël's fraudulent French history reveals her to be nothing but a conscious agent of influence of the same forces around Pitt and Bentham for whom the Jacobin terror's demagogues, Danton and Marat, were agents.

With Madame de Staël's and kindred fraudulent accounts of French history went the spread of the myth of "liberal" England as the purest and most advanced expression of capitalist development, and the complementary fraud to the effect that the United States was more or less in the condition children'sfantasy writer Karl May later still imagined it to be. Under the spell of the prevailing myths of the times, and with significant added disorientation contributed by Friedrich Engels, Marx swallowed the fraudulent account of eighteenth century (and earlier) politicaleconomic history and included those gross blunders into the empirical axiomatics of his interpretations of both history and political economy.

This problem of Marx-scholarship has been aggravated to an extreme degree by Communist as well as social-democratic historians. Any scholar acquainted with the most basic facts concerning European and American history from the thirteenth through nineteenth centuries, leafing through the appendices of publications of the Soviet Institute of Marxism-Leninism, meets wholesale batches of classifications of key figures from those centuries which are, in the main, out of correspondence with all reality. It should be stressed that this ignorance of history among such Communists is only an echo of the equally bad or worse frauds faithfully retaught as history in the public schools and universities of Western Europe and North America.

These criticisms are in no sense a matter of mootable differences of interpretation. If one turns to primary sources from the periods in question in each case, there is no correspondence between the prevailing characterization presently given in public schools and universities and the fact of the matter. What accredited textbook accounts provide is not an account and interpretation from study of the best sources, but rather a piling of commentator's gossip upon irresponsible gossip with no adequate attention to ample sources more or less readily available. The prevailing accounts of history are layers upon layers of so-called scholarly opinion concerning a mass of socalled scholarly opinion. Tracing these layers of socalled scholarship back to their point of origin, one consistently encourters some deliberate fraud, such as the cited work of Madame de Staël.

#### THE EXAMPLE OF HAMILTON

For example: Did Marx, as is asserted, discover the "labor theory of value"? He did not. He rediscovered it. The first systematic, published elaboration of the "labor theory of value" was U.S. Secretary of the Treasury Alexander Hamilton's *Report on Manufactures*, presented to the U.S. Congress in 1791, and was the basis for official United States government economic policy until approximately 1829! Hamilton, the first to use in publication the same method Marx employed to the same purpose in *Theories of Surplus Value*, refuted the British physiocratic doctrine of ground rent to prove that technological progress in increasing the productive powers of labor was the only continuing source of new wealth.

Does this suggest that Marx wittingly or unwittingly plagiarized Hamilton? We have not yet established that the republication of Hamilton's *Report on Manufactures* was among the books the American Whig economist Henry Carey sent to Marx together with his own writings. As Allen Salisbury documents the problem in the appendices,\* Marx allowed his stubborn prejudices concerning English capitalist development to prevent himself from attaining competent knowledge of either the American Revolution or the early decades of United States history. Hence, Marx refused to see that Carey, brilliantly developing further Hamilton's own "labor theory of value," had demolished Marx's error of concession to Smith and Ricardo on the subject of ground rent.

However, Mara did base the development of his

conception of expanded reproduction on Dr. Quesnay's work, not knowing that the forces of the American Revolution and French humanists Turgot, Condorcet, et al. were students of Quesnay. Although there can be no doubt that Marx did not in any way plagiarize Hamilton to develop the labor theory of value, it is obvious that Marx's later independent rediscovery of Hamilton's principle was not accidental. Marx depended significantly on the same genre of sources which led directly into Hamilton's work.

A direct study of source documents within their original context clearly establishes on all other points, as in this case, the truth of the historical problems involved.

A second major problem confronting Marx and Engels was their effort to reconcile the myth of the Ninth of Thermidor with their commendable hostility toward all ultra-left anarchist and similar declassé and lumpen-political-refuse doctrines and political tendencies. Concretely, wherever Marx confronted a variant of the ideological traditions of Danton and Marat in real life, he attacked these obscenities without compromise. Yet, he clung to the myth of the Ninth of Thermidor all the same.

This blunder causes no systematic error of note in Marx's own positive theoretical or practical work. However, Marx's failure to reject the myth itself created the opening for such influential travesties as Franz Mehring's history of the labor movement. In Mehring, rigorous historiographical criteria are cast aside in favor of an indiscriminate, maudlin pawing over every jacquerie within the centuries covered by Mehring's purported history. Although Mehring would have been early to look with abhorrence and hatred against today's neo-Fabian scoundrels, his romantic sentimentality contributed significantly to fostering the current which produced the Proletkult obscenity and the modern views of "The Left" which find a commonality among both honest socialists and outright fascists of the Maoist and kindred types.

However, back to Marx's cultural roots.

#### BEETHOVEN AND MARX

It is all fine and necessary, in studying minds such as that of Karl Marx or Ludwig van Beethoven, to focus on all the literary remains directly associated with them. However, if the investigation is left at that, no competent conclusions can be reached concerning the crucial formative influences on their development. Nor is much gained by Freudian or pseudo-Freudian study of their immediate family relations. One must study the direct literary remains associated with the person, of course. However, these sources become properly significant after one has broadened the investigation to situate these figures in their historicalcultural setting in the places in which they were raised.

For example, in the case of Beethoven studies, it has been shocking to discover that, previously, no Beethoven researcher has appropriately studied Bonn humanist culture during the 1770-1790 period. Instead of looking at Bonn of the 1770-1790 period only from Beethoven as an individual point of reference, reverse the procedure. Beethoven was a conscious humanist self-identified with the Promethean image — as was Karl Marx. Where were the Promethean humanist cultural influences around Bonn, and where do these intersect Beethoven's experience there? Bonn University was a hotbed of the Illuminati, and Beethoven's teacher, Neefe, a member of the Illuminati. Bonn was one of the centers of Herder's circulation of Franklin's influence into Germany during the period Beethoven was there. The evidence of Beethoven's fully conscious identification with the Franklin-linked Illuminati is clear once one knows what evidence is crucial — including the estate catalogue of his personal library.

It is for that reason that we include a chapter on the case of Beethoven in a text otherwise devoted to the roots of Karl Marx's development. Two interrelated issues are involved here. The foremost issue is that all known extant appreciations of Marx's cultural origins are profoundly wrong, as we show. That prevailing blunder cannot be separated from the characteristic errors of the historiographical method slavishly, wrongly employed by the investigators in question. The cases of Beethoven and Marx — as most studies of both directly reflect the same general type of historiographical incompetence — are therefore linked in a double way. Not only do Beethoven and Marx ultimately share the same intellectual roots, but the error commonly made on this point in both cases is of an identical form.

Consequently, by showing how the same proper methods of investigation apply to both cases, we are demonstrating the essential thrust of the method which must be adopted by all historians who prefer not to be judged professionally incompetent hereafter.

As we show in the text as a whole, the fundamental point of reference from which to study that process of transformation which we call history is epistemology. In particular, epistemology must not be treated in terms of collections of specific points of policy and belief, but as ultimately occupied with the relatively *transfinite* — in Georg Cantor's sense of that term — in respect to the possible array of beliefs and politics it orders in each of the various sets of circumstances.

An epistemological current, as we define it here, operates as a kind of *transinvariant*, a kind of constant ordering principle, which determines the way one set of beliefs evolves into a different set of beliefs.

The successive sets of belief ordered in this way may each be studied to define a characteristic world outlook for practice. The characteristic world outlook of such a distinguished set of beliefs may, at first inspection, be in opposition to or otherwise inconsistent with the characteristic world outlook of the set of beliefs which precedes it. We might presume, for this reason, that the two sets of beliefs are thus unrelated as world outlooks. In some instances, this may, in fact, be the case; however, such evidence is not conclusive in itself. At a higher — or, if you prefer, deeper — level of epistemological investigation, we may discover that two opposing sets of belief are subsumed by what we might call a common organizing principle, such that that organizing principle is in some way fundamentally distinct from the same notion of organizing principle as adduced for different arrays of world outlooks.

It is that organizing principle which we equate with the notion of transfinite or transinvariant.

Notably, this perception was approximated by G.W.F. Hegel in the notion of the Logos as undergoing a process of unfolding development, such that through successive evolutions in this way it subsumed specific world outlooks which were not immediately reconcilable with one another, outlooks which corresponded to distinct, qualitative stages of the development of human societies. Although our limited degree of agreement with Hegel on this point is relevant to the discussion, there is a double error in Hegel's conception of the Logos. On the most obvious side of the matter, the standpoint of historical fact, Hegel erred wildly in assuming that the accounted order of the succession of ruling forms of Mediterranean society represented a necessary succession in terms of a positive unfolding of the Logos's self-development. Hegel committed the error of post hoc, ergo propter hoc. However, more profoundly, Hegel erred in his conception of a single Logos principle. He failed to recognize that there are (mainly) at least three fundamental, distinct ordering principles interreacting in determining the course of human intellectual development.

Although Marx rejected the more simplistic distinctions of *idealism* and *materialism* which brutally flaw the literary productions of the Soviet Institute of Marxism-Leninism, he veered significantly, and Engels more notably, toward that disorienting perception. In fact, *idealism* and *materialism* as

epistemological categories (as generating or ordering principles) are sheer nonsense in the light of any competent study of the history of Mediterranean and European thought. These nonsense categories are not the transinvariants of epistemology.

In the approximately two-and-one-half-thousand years of Mediterranean civilization, there are three basic ordering principles which qualify as transinvariants. We give their paired names; the first name of each of these three is the classical archetype, the second the European epistemological name. These are Apollonian-Aristotelian (Euclidean, non-Euclidean), Dionysian-nominalist (monetarist, empiricist), and Promethean-Neoplatonic.

It is clear that Hegel intended to make an approximation of the Neoplatonic principle the equivalent of his universal Logos. This side of the matter shows Hegel at his relative best. He correctly perceived that the Neoplatonic outlook was the only one which converged on universal reality (natural law). This was not remarkable, since Hegel, like Beethoven and Marx, was a product of Neoplatonic influences. However, insofar as Hegel was correct in this aspect of his impulses, he wrongly — inadequately — judged the nature (and the historical efficacy) of the anti-Neoplatonic currents.

The study of these three generating principles depends upon understanding the mirror relationship between those outlooks, as a method of knowledge-forpractice, and as a mode by which the individual determines his or her sense of personal social identity. This is crucial to the two principal subjects, Beethoven and Marx, considered here. The issue of a youthful epistemological influence is the matter of determining how this influence has shaped the subject individual's sense of personal social identity usually by no later than the end of adolescence. There may be exceptions to this, but such exceptions represent a more complex case than we are considering here.

In the study of Karl Marx, the complementarity of the sense of identity and world outlook is most dramatically underlined as we examine the way in which Marx worked within the framework of the two principal errors of historical fact which otherwise flawed his work. Marx accepted and vigorously defended, almost to the point of an obsession, the myth that English capitalist development was the prime historical model of reference and David Ricardo its most advanced proponent. Yet, working within the framework of that delusion, he otherwise developed his systematic, internal analysis of capitalism in a way which, on all main points, entirely corresponds with the correct view of English capitalism. Marx accepted, on balance, the fraudulent myth of the Ninth of Thermidor. Yet; in every case Marx absolutely

There is a crucial connection between that feature of Marx's later work and the evidence of the 1835 Aufsatz. The controlling influence in Marx's development, his evolution of his powers of judgment, was the sense of personal identity established by the end of his adolescence. The intensity of that correlation is relatively exceptional. There are few historical figures who exhibit that same degree of ruthless intellectual integrity. However, the operation of this same principle is not otherwise exceptional in a notable historical figure, and operates in fact in the ordinary individual case of everyday life. One's view of the universe as a whole is in the last analysis a reflection of one's ruling moral sense of personal social identity, the sense of what cannot be sacrificed without losing what one regards as one's essential moral identity as a person within society.

It is for such reasons that soldiers risk death in battle.

In studying the three archetypes we have cited above, one can start from two points of reference to arrive at the same result. It is the combination of both points of reference to this effect which provides the essential degree of comprehension wanted. On the one side, one can consider the circumstances in which the Apollonian, Dionysian, and Promethean outlooks arise historically. On the other side, one can examine the same problem from the standpoint of the maturation of the infant, child, and adolescent. Taking both together, this is another way of exposing the mirrorimage relationship between the ordering principle of world outlook and the person's sense of moral identity.

The Promethean and Apollonian outlook are commonly distinguished from the Dionysian outlook by the fact that both define the universe as ruled by universally and comprehensively efficient and coherent universal laws. The Dionysian makes his sensual, individual self the center of the universe for knowledge, and demands "areas of liberty" for his will (and the wills of others) within which universal law ceases to be fully, coherently efficient.

The Apollonian regards universal laws as permanently fixed in all their implications.

The Promethean regards universal law as what we would properly today call "negentropic." The Promethean regards the universal law as one of selfdevelopment, and man as an efficient agency for acting lawfully to promote such self-development.

The Apollonian views the universe in terms of fixed objects of fixed qualities, and regards universal laws principally as the ordering relations among those objects. Although the Dionysian rejects the Apollonian's comprehensive coherence for universal law, he accepts the "field-particle" notion of the ordering of phenomena otherwise distinguishing the Apollonian from Promethean view.

These distinctions in outlook are directly associated with different conceptions of the morally acceptable understanding of the human will. The Apollonian regards any deviation from a predetermined form of lawful behavior as error (sin) which must result in a countervailing action by the universe to correct this error (penalty). He concurs with the nominalist so far as to define a range or error which separates tolerable error from a greater deviation, which is outlawry. The Promethean accepts no notion of toleration in the Apollonian sense, but regards freedom of the will as properly action by man consistent with the lawful principles of development of the universe.

Freedom is not violation of natural law, but is creative discovery, which enables man to alter universal law in a way prescribed by universal law. Scientific knowledge as the informed basis for changing the world is the paradigm for such freedom, such exercise of the will.

The Dionysian defines freedom as *irrationality*, as an existentialist assertion of egoistical, sensual, and analogous individual impulses *in spite of natural law*.

The Apollonian view is characteristic of bodies of opinion which attempt to resist both progress and degeneration, to perpetuate and perfect the natural law in its presently misdefined condition. The Promethean view is characterized by the commitment to scientific progress as essential. The Dionysian view (*omnia contra omnes*) is the anarchist view, the licentiousness of the immoral declassé, the criminal element, the lumpen, the individual or group which places itself into opposition to those general social interests which are contrary to its impulses.

The Dionysian view corresponds in the maturation of the individual to the infantile view, the Apollonian to the "good," obedient child and adolescent, the Promethean to the adult who must achieve moral identity in the society as a whole by contributing or extending some innovation which is of lasting value as the foundation for the future progress of society.

The three types are illustrated by the way three different persons might treat a persistently badly functioning television receiver. The Dionysian (the infantile person) kicks the instrument. The Apollonian seeks advice from an authority. The Promethean discovers a better instrument.

The complementarity between world outlook and moral identity is approximated: "This is what the universe as a whole must be, and therefore this is your proper identity within it."

It is the way in which that sense of moral identity is

tions.

transmitted to and fostered in the developing individual which is crucial, and most decisively crucial, in understanding the dominant figures of our culture. Indeed, the education of the young, taking the notion of education in its proper, broadest sense for this purpose, is essentially the youth's search for a moral sense of adult identity: "Who" — not what — "am I going to be when I grow up?"

It is that induced sense of moral identity which the emerging new adult applies as the governing standard of judgment for those ideas and issues which he encounters.

In Marx's case, turning again to the powerful influence of his ignorance concerning vital facts of the sixteenth, seventeenth, and eighteenth centuries, which separates him often from such great Neoplatonics as Condorcet and Hamilton among others, Marx nonetheless stands out as reaching the same world outlook as Franklin's follower Carey on all of the important issues of the Civil War in the United States. This occurred despite the fact that Carey's perception of the eighteenth century and of English capitalism was correct, and Marx's flawed on those counts of difference even though Carey was an industrial capitalist politically and Marx a socialist. This coincidence reflects the powerful integrity flowing from Marx's Neoplatonic sense of moral identity. Given the same facts, any Neoplatonic of strong integrity must tend to generate approximately the same practical judgments.

Turning to the Illuminati and Freemasons of the eighteenth century, not only did they include strongly prohumanist (Franklin's allies) and violently antihumanist (the allies of Pitt, Hume, Bentham, et al.) currents in the same organizations, but this complexity is characteristic of all of the associations of that period (in particular). Commonality of association, coincidence in factional support of strong issues, and so forth, are not intrinsically reliable guides to history. Moreover, just as most adults are partly infantile in their personalities, two outlooks, the inferior one always tending to the infantile-Dionysiannominalist outlook, usually operate in personalities. Hence, an individual may transmit one outlook at one time, and another at another.

#### THE FALLACY OF "IDEALISM" VERSUS "MATERIALISM"

We can study the intellectual collapse of the old social-democratic pro-Marxian and Communist organizations of the OECD countries from various standpoints of initial reference. It is necessary to recognize that in general these organizations were destroyed by included means of externally applied containment and subverson. However, this account, while indispensable to reaching the whole truth of the matter, leaves certain most crucial facts unnoticed. The transformation of the characteristic, internal world outlook of these organizations is equivalent to a transformation of the genetic specificity of an organism — and not only in the heuristic sense. We must inquire what were the epistemological weaknesses, the weakness or lack of an active generating principle, which made such a genetic transformation possible?

The recent paper of Dr. Richard Pollak\* and the companion paper by Dr. Ned Rosinsky\* identify the important discoveries occurring in biology concerning the process of mutation, which bear directly on this. It is argued that the origin of mutation is not in the "string of beads" aspect of the genetic material, but that these genetic materials provide an essential part of the conservative forces, so to speak, processes which regulate the stability of an evolved species or variety. The fact, as reported by Pollak, that special changes in the thermodynamics of the total environment have been rigorously proven as causing permanent, heritable mutations in variety, shows for biology the operation of the same principles previously proven to rule for societies and the directed, negentropic evolution of the biosphere as a whole.

To the uncritical observer, such demonstrations may appear to be a simple resurrection of the Lamarckian notion of determined inheritance. More immediately, the echoes of the "Lysenko controversy" are heard. Some comment on this is much in order, to clear the way for what must be considered in respect to the myth of "idealism" versus "materialism" as a contributing element in the internal decay of socialist organizations of the OECD countries.

First, in conditional defense of Lamarck and Lysenko.

Lamarckian views originally developed as a byproduct of the Neoplatonic humanist ferment persisting strongly in eighteenth century science. Working from the principle of Ibn Sina, the principle which was the guiding conception of all the achievements of the European Renaissance and Enlightenment, the fact that the realization of human creative discoveries in the form of more powerful scientific knowledge represented man's mastery of the laws of the universe signified that the Idea of Progress must be the fundamental lawful principle underlying all categories of phenomena. If one consi-

\* Dr. Richard Pollak, "Evolution — Beyond Darwin and Mendel," and Dr. Ned Rosinsky, "Drosophila Embryology — The Dynamics of Evolution," in *Fusion Energy Foundation Newsletter*, Vol. II, No. 4 (May 1977), pp. 42-53, 54-59. ders the problem of physics as posited by Leibniz's *Monadology*, and considers the work of Lagrange from this standpoint, the basis for Lamarck's attempted application of the humanist principle of evolution is immediately grasped.

Although Descartes set out to establish the principle of the relativistic continuum for physics, as is not to be doubted when his work on physics is compared with his definition of *perfection*, until the work of Riemann and the important complementary work of Cantor – a span of two centuries of physical science — the problem of formally conceptualizing a negentropic principle within the domain of physics as such remained essentially unsolved. Hence, Lagrange and others, although working under strong, Franklin-shaped humanist influences within the group of the Ecole Polytechnique, failed to get beyond a mechanistreductionist conception of the formalities of physical science as such. Hence, Lamarck, proceeding from an essentially negentropic conception of evolution on the one side, developed his argument in reductionist terms of explication. He attempted to define a negentropic principle in evolution in mechanistic, entropic terms of practical reference.

Therefore, Lamarck's work has great epistemological interest in the study of biological science, but no direct applicability in the form it was advanced.

From the more recent material assessed by Pollak, we have fresh insight into the kind of work done by Michurin and Lysenko. They had clearly struck upon experimental evidence of the type which has been more rigorously conducted since that time. Until the relevant files of the appropriate Soviet agencies are researched afresh from the standpoint outlined by Pollak, we shall not have an adequate appreciation of the background to Lysenko's thesis. However, as with the case of Lamarck himself, the official version of the Lysenko thesis skidded over the crucial point, thus contributing to the discrediting of valuable research by blind zeal in placing a theory where an incompletely developed hypothesis, replete with question marks, should have been offered.

This aspect of the Lysenko problem is immediately representative of the kinds of devastating blunders to which any simple counterposition of "idealism" and "materialism" must lead. Reciprocally, this connection to biological science underscores the "genetic problem" to be considered in respect to the decay of socialist organizations.

Although Marx himself was deluded by falsified facts concerning English capitalist development, his guiding method otherwise was the Neoplatonic humanist outlook and sense of personal moral identity. It was this active, "genetic" feature of Marx's "character" which not only preserved but developed his elaborated outlook throughout his life. If the predicates of that principle, i.e., Marx's specific beliefs, are taken without regard to the generative principle (Neoplatonic humanism) which determined their existence, then we have what might be termed "Marxism" in the perjorative sense. Any set of beliefs, even those determined by a generative principle, if taken as specific doctrines, and so forth, represent not a world outlook but a mechanistic structure thus intrinsically subject to entropy.

This point is corroborated by comparing the leading "orthodox Marxist-Leninist" currents in the leadership of the parties of the CMEA countries with the rampaging "Eurocommunism" of the Communist parties of the OECD countries. The difference is not that the Soviet and other "hard-liners" cling to the official doctrine of "Marxism-Leninism." This could not be the case, since the principal published texts on "principles of Marxism-Leninism" and on the topics of "historical and dialectical materialism" include awful rubbish. Rather, the CMEA countries are committed to the principles of Neoplatonic humanist *practice*, to the notion of a republic committed by intrinsic character to the application of basic scientific progress to technological progress of expanding productive forces, and to the development of the general education and associated culture of the population on the basis of that program.

The characteristic of socialist thought in the CMEA countries centers around the economic plan. What most conspicuously distinguishes the socialist, Neoplatonic thrust in those countries' leading tendencies is the reciprocal connection between the forced effort for basic scientific development and the hegemony of the thermonuclear war-winning strategic posture. Machiavelli, Benjamin Franklin, Hamilton, and Condorcet would tend to thoroughly understand the Soviet currents in these terms of reference.

The problem in the CMEA countries is that on the one side the "official doctrine" is a glossed version of "Marxism-Leninism" which, taken by itself, is significantly rubbish. However, the Neoplatonic, predominantly "hard-line" currents in the CMEA countries' parties' leadership strata interpret that doctrine from the standpoint of a Neoplatonic humanist generating principle.

In contrast, in the OECD countries, in which the majority of Communist parties' leaderships are essentially heirs of Locke, Hobbes, and Rousseau rather than of Hegel and Marx, the opposite generating principle, the nominalist generating principle, has operated. Hence, we have the pattern of a long period of moral and intellectual decay, previously contained within the terms of reference of the accredited doctrine, which, at a threshold-value point, erupts in the forms of Merleau-Ponty or the present Eurocommunist tendency.

The "hard-liners" of the CMEA countries are organically Marxist. Although generally more primitively developed intellectually than Marx himself, they independently replicate the same quality of generating world outlook represented by Marx, and react to the obsessive errors of their official doctrines with the same sort of corrective tendencies for practice shown more conspicuously in the work of Marx himself.

At the same time, as is the case for the eighteenth century factional forces among the Freemasons and Illuminati, the Gironde and the Jacobins, the Communist parties are not morally homogenous either within or outside the CMEA countries. There are those in the highest circles of the CPSU who, like Georgii Arbatov, represent the most degraded, nominalist outlooks, and who, at best estimate, are not socialists in fact but merely Soviet patriots. There are organic socialists within the Communist parties of the OECD countries, despite the hegemonies of Carrillo, Marchais, Berlinguer, and so forth.

This sort of evidence absolutely does not warrant a preference for the nominalist historiographical doctrine of "factors." The chaotic picture which first emerges from looking at the phenomena in terms of carried-forward criteria merely demonstrates that the wrong criteria, the wrong method have been applied to the investigation. What has been lacking is the understanding that the relevant problems of historiography are methodologically identical with the problem of the transfinite as successively developed by Riemann and Cantor. The world has been viewed from the wrong standpoint of reference and by the wrong method.

Marx himself implicitly refuted the idealismversus-materialism nonsense in its entirety in his famous "Theses on Feuerbach." In fact, those "Theses" are not only a direct restatement of the Neoplatonic humanist view in the most basic terms of reference, but, excepting Riemann's self-conscious efforts to redefine physics entirely from the standpoint of negentropy as the unique universal principle, Marx's theses represent an unmatched statement of the case for Neoplatonic humanism until our own, more advanced accomplishments in this connection. Indeed, it was this writer's own recognition, beginning approximately 1952, that the standpoints of Riemann-Cantor and Marx must be unified to reach a comprehensive solution to the problem, which ultimately led directly to the qualitative supercession of the work of both Riemann-Cantor and Marx.

The case of Hegel suffices to prove the absurdity of the effort to define "idealism" and "materialism" as distinct epistemological currents. Nothing is more grossly absurd, more profoundly incompetent, than to propose that Marx overthrew Hegel by asserting the materialist point of view for the dialectical method.

The flaw in Hegel which Marx corrected was in fact Hegel's refusal to break with the classical materialist point of view in respect to physics. Hegel, elaborating the Neoplatonic humanist outlook comprehensively for the intellectual process of human development, accepted the physics of Lagrange as converging upon perfect knowledge of perfected universal physical laws. Hegel was concerned to follow the path of Heraclitus in attacking the problem of showing that the physical universe was created dialectically, but at the same time he regarded Lagrange's physics as reflecting — at least epistemologically — the perfected state of that universe. Hence, Hegel denied the efficiency of human creative thought in respect to further evolutions of the lawful state of nature. Hence, for Hegel, Lagrange's physics became his Seelensack; Lagrangian epistemology represented an impenetrable sack which contained (for Hegel) the freedom (creative powers) of the human mind.

In the second of Marx's "Theses," this Hegelian Seelensack was directly ripped asunder. Hegel's delusion concerning the Lagrangian determination of physical necessity was overthrown as "a purely scholastic question."

Hegel's problem was replicated in principle, although differently, by Feuerbach, Feuerbach inverted, so to speak, the classical materialist particlefield relationship, making the "field" the primary existence. Hence, his denunciation of the protofascist reactionaries, Bacon, Locke, and Hobbes, on this account. However, Feuerbach defined the subject, the field, as primary with respect to the predicated phenomenal order of nature as described by the mechanists. Hence, Feuerbach's slogan, "backwards I agree with the materialists, but not forwards." So far, contrary to Engels, Feuerbach was correct. However, as Marx emphasizes correctly in the first of the "Theses On Feuerbach," Feuerbach's refusal to give up the fixed existence of the determinate (not self-evident) particle in the Spinozan field caused Feuerbach to reach judgments contrary to Feuerbach's own conscious intention. By accepting the self-evident particle as a reflection of the principles of the Cartesian-Spinozan "field," Feuerbach prohibited practical-revolutionary activity. Feuerbach posited, with Descartes and Spinoza, the principle of freedom (creative scientific progress), but accepting the phenomena of the self-evident particle, Feuerbach



Benjamin Franklin's influence was widespread throughout Europe as well as America. In the course of his twenty years' residence in London and during his service as the United States' Ambassador to France, Franklin developed contacts in all major scientific and learned societies, in industry, and in Europe's courts. By 1789 his essay, "The Way to Wealth," had been published in 70 editions, in all major languages, in Europe and America. Shown above are a small selection of the leading figures of the 18th and early 19th centuries who were influenced by Franklin's organizing and outlook. Cities shown on the map were either visited by Franklin personally, or were centers of his humanist colleagues and followers.

In sum, the flaws in Hegel and Feuerbach were precisely that they refused to break entirely with classical materialism. They rejected the epistemological generating principle of classical materialism, but they aborted this attack upon Aristotelianism and nominalism combined by making the phenomenology of the nominalists a kind of *Seelensack* which they declined to rip asunder.

Marx freed dialectics of "idealism" by breaking entirely with the doctrines of classical "materialism."

The same point is efficiently made with respect to Immanuel Kant. Kant was essentially a member of the anti-Newtonian faction of Leibniz. He was essentially in the same anti-British faction as Benjamin Franklin, in that he wrote his most famous work, *The Critique of Pure Reason*, as a conscious effort to destroy once and forever the enemy doctrines of nominalism (indifferentism) as represented by the foul British political-intelligence operative, David Hume. The case of Herder and of Marx's teacher Wyttenbach are relevant. The preface to the first edition of the *Critique of Pure Reason* is one of the most penetrating and devastating attacks on today's British ideology ever composed.

Kant's problem was of the same genreas Hegel's and Feuerbach's. Although Kant was fundamentally opposed to such conscious enemies of humanity as Bacon, Newton, Locke, Hobbes, and Hume, his opposition was largely delimited to the domain of abstract epistemology, and otherwise to the principle of basic scientific progress as the proper governing practical principle of progress for society. Three aspects of Kant's work are the proper foci of criticism.

The first criticism to be made of Kant is that made by Hegel. Kant was politically impotent; he refused to acknowledge an efficient, practical connection between freedom and understanding: hence, the antinomies.

The second and third criticisms to be made of Kant's work are his varied deferences to Rousseau and Lagrange.

Like many credulous leading thinkers of the late eighteenth and early nineteenth century, Kant was ignorant of the fact that Swiss bankers' political agent Jean-Jacques Rousseau, the "left-anarchist" side of Necker, was essentially rewarmed Bacon, Locke, and Hobbes. Kant failed, like many others, to recognize that Rousseau was not only reactionary with respect to his role as a political agent of monetarist-feudalist reaction, but that Rousseau's political role was everywhere represented in the bestiality of his thought.

Because Rousseau's empiricist, implicitly protofascist conception of the field-particle relationship corresponded to the mechanistic side of the Lagrangian schema, Rousseau was cheerfully mistaken to be a well-meaning "egalitarian" in respect of the "particles" of which society is composed. The "muckraking" aspect of Rousseau was accepted as such, and by accepting this aspect of the vile Rousseau, the fascist side of Rousseau's outlook was regarded as something to be tolerated for "friendly criticisms and corrections."

It was just this stupidity respecting the Neckerlinked Rousseau doctrines which prompted the Necker-linked Maximilien Robespierre to cheerfully preside over the Danton-Marat destruction of everything which Robespierre himself otherwise esteemed himself to prize.

This influence shows up in Kant's quasi-anarchism. By accepting in part Rousseau's ostensible parallels to the Lagrangian model of the universe, Kant reverted to the classical Aristotelian or scholastic conception of the "categorical imperative." Despite the fraudulent neo-Kantians, such as Lange, Bernstein, et al., Kant was no anarchist, no Rousseauvian, no neo-Kantian. His degenerate side was entirely Aristotelian; his notion of democracy was in effect classically scholastic; he accepted absolutely the notion of efficient and comprehensive universal law, and also the absoluteness of the principle of freedom. On this account, he is usefully compared for study with the most advanced Jesuits.

It was for such reasons that Hegel justly denounced the implications of the *kantsche Seelensack* as a separation of freedom and understanding which must lead directly to dangerous mental pathologies, poisonous fantasies.

The key to Rousseau is the "noble savage," as we shall treat the implications of that below.

In the official Soviet and parallel efforts to make a distinction between "idealism" and "materialism" several profound incompetencies are most conspicuously involved.

First, what the Soviets properly mean by their formal definition of idealism, is *nominalism*. However, as the productions of the Institute of Marxism-Leninism illustrate, they are ignorant of the essential characteristics of nominalism. They thus put themselves in the absurd position of regarding the most hideous nominalists as "historically progressive materialists," and deprecating with even greater absurdity some of Marx's greatest direct predecessors as flawed, relative to the nominalists, by "reactionary" tendencies toward "idealism."

Nominalism, by placing the heteronomic will as superior to the laws of the universe, converges on the ultimately fascist doctrine of the "social contract," the doctrines of the raving pro-Stuart reactionary, John Locke, and the morally imbecilic apologist for fascist dictatorship, Hobbes. Whatever the heteronomic wills of ruling forces compact to make the law of human behavior (social-contract versions of positive law) is superior to the laws of nature. That is pure idealism, which Soviet sources grudgingly concede to be the case to the extent that they speak of *metaphysical materialism*.

What those Soviet sources (and related sources) obsessively refuse to get through their stubborn heads is that since man is a part and product of the universe, the power of the mind to create scientific knowledge through which societies increase their power over the universe and its laws, is itself the one and only fundamental principle of all human knowledge, the only fundamental, empirical basis for man's knowledge of the unique, coherent, and comprehensively efficient actual laws of the universe as a whole.

They call themselves Marxists, but on this issue they are often crude, pre-Feuerbachians. Whereas Marx himself, as in the "Theses On Feuerbach" in the "Feuerbach" section of The German Ideology, makes the revolutionary aspect of scientifically driven progress in social practice the unique and only source of fundamental human knowledge, the Soviets revert to the worst errors of Kant — yes, precisely the errors of Kant, which is why they are unable to competently criticize Kant — in dividing the universe into Lagrangian nature plus man. The Soviet authors of the idealism-versus-materialism theses are therefore themselves raving idealists in fact. Hence, their softness toward reactionary nominalism, on grounds that it is dubbed relatively the "progressive movement" of materialism. The Soviet authors involved are not nominalists generally, although Georgii Arbatov himself is nothing but a raving, reactionary nominalist; they are Aristotelians in the tradition of Kantian critical philosophy.

Although Marx himself accepted the literary categories of "idealist" and "materialist," his writings do not reflect the slightest correspondence with the predominant Soviet and related usages of those terms otherwise. The first and second of the "Theses On Feuerbach," the "Feuerbach" section of *The German Ideology*, and the treatment of Freedom and Necessity in the final section of Volume III of *Capital* are a consistent development of the same Neoplatonic humanist conception, a drive differently reflected to the same ultimate effect in the work of Riemann.

Friedrich Engels himself is a less clear-cut case. Apart from the fact that Marx partially shared with many other German republicans of his generation the myth of English "liberalism," it was Engels's misguided insistence on the continuing preeminence of British technological progress in capitalist development which swayed Marx significantly to favor the delusion involved. Engels was similarly at fault respecting Marx's disoriented perception of the nature and implications of nineteenth century trends in the physical sciences. Engels's unfortunate "Ludwig Feuerbach," and a related comparison of Marx's "Feuerbach" section of *The German Ideology* with Engels's fragmentary effort at writing that same section, are most pertinent. Although Engels is not the author of the pathetic "dialectical materialism" circulated by Soviet sources, it must be admitted that he opened the door through which others moved into such directions.

If the Soviet scholars wished to show a consistent line of development of the kind of "materialism" represented by the cited writings of Marx, they would be obliged to begin with the greatest thinker of the Arab Renaissance, Ibn Sina. It was the direct influence of Ibn Sina's conception of the creative powers of the human mind as necessarily a reflection of the fundamental law of the universe which directly engineered the entirety of the humanist currents of the European Renaissance. They would include Roger Bacon, Dante Alighieri, Ficino, Pico, Erasmus, Gresham, Bodin, Gilbert, Raleigh, Bruno, Colbert, Milton, Quesnay, Franklin, Turgot, Condorcet, Liebniz, Descartes, Spinoza, Kant, and Hegel as a coherent line of epistemological development leading directly into Beethoven and Marx. They would ridicule any effort to describe any figure in that coherent epistemological progression as an "idealist."

The fundamental epistemological issues of the history of human thought are, as we have emphasized above, the question whether universal natural law is comprehensively efficient, and, if so, is that universal law negentropic or entropic. From that standpoint, the only historically meaningful use of the term "idealism" is the nominalist current which places the heteronomic will of man acting without regard to universal natural law above natural law in efficiency for social practice. Nominalism, indifferentism, and monetarism are the same thing, and represent the only coherent current of thought which can be meaningfully described as "idealist."

# THE DAMNED "VOLKISCHE" DOCTRINES

Throughout much of Soviet historical writings, continuing the sentimental tradition of the Prussian social-democratic romantic Franz Mehring, one reads interminably of the "heroic struggles of the people." This populist crap, this seepage of sewage from the traditions of Rousseau and Marat, has done more to destroy the socialist movement from within than any other cause.

What was "Operation Barbarossa" but a struggle of the German People to relieve the oppressive material conditions of life in the Third Reich by looting foreign countries? What were the subhuman wretches of Wallenstein's horde but "great masses of the people" seeking to alleviate the oppressions of hunger by preying upon the very fabric of society like a plague of cannibalistic locusts? What were the fascist mobs of Paris, ranged behind British-agent demagogues Danton and Marat, but the same degraded, reactionary "people"? It is past time to extirpate this degrading, sentimental crap once and forever from the pages of historiography.

The essence of human existence, as human, is the development and realization of the creative powers of the mind as the instrument for advancing the human condition through increasing man's power over nature. How, in the entire sweep of human existence, has progress been attained except through the production and realization of social surplus product? It is the application of new conceptions to social surplus product, the development of the productive powers of man over nature, upon which everything depends. Anything contrary to that is bestial crap, which has nothing to do with all those qualities we rightly esteem as human.

Since the beginning of the Crusades in Europe, all European culture has been divided between two principal factions. On the one side were the intellectual heirs of Ibn Sina, the Neoplatonic humanists. On the other side were the fascists — the nominalists, the monetarists, often with the Aristotelians as allies against the human race.

The humanists proceeded axiomatically from the standpoint of progress. Science was a political cause — until scientists were later induced to forget, for a while, what science is in fact. The development of the powers of mind to create scientific knowledge, knowledge which in turn informed the general and individual will for social practice, was always the center of humanism. The use of science to develop the productive forces, to consciously increase man's power over nature as the mediating precondition for the education and cultural development of man in general, was the essence of this struggle.

To this the scholastic reactionaries said "No! Man was perfected in the Garden of Eden, and can go no higher. Man has merely fallen from Grace, and must work his way back to that already perfected condition he has lost through ignorance and sin."

The fascists, the nominalists, presented a different argument against humanism. They said: "No! Man is intrinsically evil and violent against man. Perfection

į

is an impossibility. There never was and never can be an efficient rule of social practice by natural law. Man can deliver himself from the consequences of his intrinsic evil only by social contracts and governments to enforce such social-contract forms of the simply positive law."

Kant is thus clearly a humanist. His denunciation of heteronomy in his *Critique of Practical Reason* locates the evil in actual man entirely in his misconception of himself as a Rousseauvian or Lockean individual. Progress is necessary; it is the single imperative which is the expression of freedom through creative scientific discovery which masters the universe with increasing power for social practice. Kant was powerful against the fascists — Locke, Hobbes, and Hume, but impotent before the task of making the principle of freedom *efficient*.

In essentials, the struggle between humanism and the wellspring of fascism (nominalism) was a struggle for and against the Idea of Progress. This counterposition of policy represented the conscious, self-conscious distinction between the humanists and the nominalists. The humanists proceeded both in policy and in moral sense of personal identity from the necessity for progress in man's productive powers over nature, and the conception of rigorous scientific knowledge as the indispensable mediation of that progress. The bestialists rejected above all the creative powers of mind to master the actual, comprehensively efficient laws of the universe for progress. The "noble savage" and similar forms of "cultural relativistic" advocacy of bestialism (man as like a beast, with fixed behavioral tendencies like a lower beast) were the point at issue.

The cases of Bacon, Locke, and Newton as conscious political reactionaries are most relevant.

At the close of the Elizabethan period, the most conspicuous leader of the humanist faction in England was Sir Walter Raleigh. With the accession of James Stuart, Raleigh was imprisoned on fraudulent charges and subsequently beheaded as the sealing of James I's treachery against England in cahoots with the Hapsburg and allied financier forces. The Queen Mother of France has an interesting connection in this matter.

Francis Bacon, quondam Stuart Chancellor of the Exchequer and generally an arrant scoundrel and embezzler, was a key figure in the antihumanist cabal and in James I's treasonous betrayal of England to its enemies. No one who has studied Bacon's *Novum Organum* from the standpoint of knowing the principal extant scientific and related writings of Giordano Bruno or the English humanists could imagine that there was anything even slightly progressive for science in Bacon's writings. The image of Bacon as a leader in the progress of scientific thought is pure

hoax. Exactly the contrary; Bacon's argument is against the previously established scientific progress, in favor of the nominalist-monetarist forces by which this filthy traitor was paid.

John Locke is a contemptible wretch fully in the worst aspects of the tradition of Francis Bacon. His writings, like those of the despicable Hobbes, are scientifically noteworthy solely for their clinical interest. They state the case for heteronomy with such exceptional thoroughness that they represent not only the principal forerunners of modern fascism, but are the exemplary references on this subject. Locke, like Hobbes, was a political agent for not only the Stuarts, but for those French and Amsterdam agents for whom the Stuarts were essentially paid agents, like Locke himself. Both were imbued with the deepest hatred of humanism, notably of Milton, and of everything which hinted at republicanism.

The Scottish lowlands aristocracy has proven since the middle of the sixteenth century one of the principal festering places for every evil which has squatted upon England. This role of the Scottish aristocracy has not been accidental. Essentially, at a time when England under humanist leadership was arising from the bestiality of medievalism into urbanized industrial development, those damned Scottish lords and their brutish underling landlords represented the very decayed bowels of past British history. A contained Scottish highlands, still living in the middle of the preceding millenium, was complementary to the lowland serf living under the most hideous landlord rule.

Intrinsically backward to the point of bestiality, perennially bankrupt, and wanting the rudiments of what passed for Christian morality in more advanced centers of Europe, these miserable Scottish nobles were a ready market for any foreign agency which jingled the requisite amount of hard coinage under their unwiped noses. Their loyalties were as labile as they were mercenary in essence. Their attitudes toward progress would make Adolf Hitler appear a passionate humanist by comparison.

All six of the Stuart monarchs of England (if one counts Mary) exhibited that national trait of the Scottish nobility in the extreme. All of them were conscious and paid traitors to the nations whose throne they occupied, and their immediate retinues operations devoted to destroying the humanist influence and subverting and crushing the networks of associations of humanists around art, science, and politics.

Colbert, himself a master of political-intelligence networks, and Leibniz organized humanist counternetworks against the circles centered around Locke and Newton, networks penetrating England and seeking connections in the English plantations in America. Benjamin Franklin was the principal connection for the overlapping networks of Colbertistes and Leibniz heirs in America.


Given the abysmal ignorance prevailing in universities and university-educated circles generally today, it first appears incredible to today's so-called educated individual that the two factions arrayed against one another could have been so fully conscious on so many fronts of combat. For example, the Royal Society in London, informed of the work of Johann Sebastian Bach in Leipzig, decided that Bach's welltempered system was a cultural influence for humanism, and launched a covert operation, focused on Leipzig, aiming to isolate and discredit Bach. Montesquieu was a paid agent of British circles and wrote his work under the sponsorship of British circles who knew the political benefits of Montesquieu's frauds. The operation focused against Wilhelm Fürtwangler by Anglo-American political-intelligence forces during the postwar period was scarcely without precedent. The cultivation of the cult of the twelve-tone scale, launched through Anglo-American intelligence services during the 1920s, and the more recent cultivation of "Rock," represent a conscious continuation of antihumanist principles, which recognize the danger to their political hegemony in humanist impulses within art and the physical sciences.

Scottish aristocratic scion David Hume, agent of the British foreign office who spent approximately ten years in France building up networks to subvert the humanist faction of Colbertistes, wrote his so-called philosophical works as a conscious operation against humanism. Similarly, Jeremy Bentham was nothing but a leading political intelligence operative and coordinator of covert "wetwork" operations for the British East India Company, as was his accomplice, James Mill. Adam Smith was not an economist but another

were characteristically the paid sycophants of degraded mercenaries.

The formation of the Royal Society in England under the Stuarts had a double purpose. Its overt function was to coopt and thus contain scientific progress along lines agreeable — or least disagreeable — to the Stuarts and their employers. At the same time, the Royal Society was the nominalist's "CIA" of its time, the center of a vast network of agents and covert one of the same tribe, writing a hoax intended — with aid of massive, conscious lying included — to discredit both the Colbertistes and the influence of the American Revolution.

In general, during the eighteenth century, the humanists and the London-led bestialists each recognized what was humanist and what was antihumanist in art, science, and philosophy, and in political economy. They knew from experience how humanism

in art directly connected to humanism in science and political economy, and vice versa. There was no significant aspect of cultural influences in any part of the accessible world which the London-based bestialists did not undertake to subvert and crush by any and every means available.

Granted, nominalism was what Scottish aristocrat's mercenary morality believed. It believed in Locke, Hobbes, and Hume. It believed in the cause of bestialism, as that cause which best served the interests of its paymasters in the banks of London, Amsterdam, and Geneva. Nonetheless, believing in nominalism with a mercenary sort of passion or not, they fought to spread nominalist, antiprogress conceptions against humanist conceptions by every and any means, in every accessible avenue of social life.

In strategy, the bestialists had two, complementary methods for fighting the humanists forcibly. In the ordinary circumstances, an assassination here and there, a deployment of regular forces, buying corruptible persons and groupings to crush a humanist project, were the axiomatically deployed means of London, Amsterdam, Geneva and their Guelphcentered allies. When these ordinary means proved inadequate by themselves, London and its allies resorted to judo. "Judo" meant, in general, provocation. Provoked social crises, provoked and fostered wars in which the opposition would bleed itself to a suitable degree of weakness and popular discredit, and, always, the use of "left" demagogues to whip up "the people."

The British aristocracy, whose public school and university life emphasized Latin and sodomy with a bit of Greek, resorted repeatedly to the lesson of the fall of the Roman republic. The lumpen urban mobs and jacqueries were mobilized as a battering ram of irrationality and havoc. The classic case was Pitt and Bentham's use of their agents Danton and Marat to destroy the French Revolution's humanist faction. British agents used the same methods in their subversion of the United States. British agent Aaron Burr (of the Bank of Manhattan) established the power of the Democratic Party by buying up immigrant votes. The lumpen, the immoral declassé, and the politically backward rural strata were the principal stock-intrade of the British foreign office for years. Jacobinism and anarchism into a special, twentieth century variety.

It is this filth which simpering, sentimental, wouldbe socialist writers invoke with their indiscriminate adulation of the "voice of the people." Such populism ~ has nothing in common with the outlook of Karl Marx.

Both Aristotelian and Neoplatonic Christian theology have correctly and consistently recognized that the evil in individual man is identical with the sort of materialism which the nominalists profess. In terms of analysis, Marx's views on this subject differ not at all from classical Christian theology. The connection among these converging views on the subject is crucial to understanding the problem.

As soon as man begins to produce his means of existence, rather than living like a lower, food-gathering beast, he confronts himself with a fundamental problem which thereafter determines the necessity of human existence. As man makes even the slightest changes in his mode of existence along lines we today generically describe as productive technology, he gains in power over nature to the effect of increasing the number of useful calories per capita throughput of his mode of production and consumption. However, in so doing, he has introduced a necessary condition for his existence which is not to be found in nature without man's activity to that effect. This new condition, at each qualitative step in technological progress, has the following driving contradiction. By raising himself above what the ingenuous term "natural conditions," man exploits those "natural conditions," such that aspects of nature, in "original" or man-altered condition, become what we term primary resources. Since man is existing at a higher level of per capita energy throughput than is provided for him in "the natural condition of nature," those aspects of his environment which he regards as primary resources become relatively finite. This circumstance is such by definition that even by constricting or reducing his population — if that were possible — he would be exhausting the possibilities for continued human existence in that prevailing mode of technology. Man solves this problem only through creative discoveries which, as realized, raise the negentropy of his mode of existence to a still higher level above that for beastman in "natural nature." Thus, once man rises out of a beast-like condition, the capacity which enabled

The demagogue populists, the "friends of the people," from the raving fascist, British agent Marat, from the Tories' agents of the American Revolution onwards, have been the ultimate political means by which a relatively tiny handful of bestialist scoundrels have ruled and degraded great nations. Mussolini's fascism, the Nazi variety, and other cases have been nothing but a twentieth century outgrowth of leftthat, his potential for realizing creative scientific discoveries, becomes the driving necessity of human existence.

This necessary progress is realized by the concerted action of the minds of society to initiate new equivalents of basic scientific discoveries and to transmit those discoveries, as informed will for social practice, to the mode of production and related aspects of

culture. This is accomplished through transforming a social-surplus fraction of the total productive forces available into the means for realizing innovations for practice.

That being the case, if men in any society separate themselves in notions of self-interest from the advancement of their society as a whole, then to such views progress is impossible. The cooperative fostering and realization of innovations, the allocation of a social surplus to such purposes, becomes impossible. Yet, having rejected the instruments and institutions of continued human development, such persons have not escaped the rigorous necessity. The depletion of a prevailing mode of culture closes in upon the society, either objectively or by virtue of the inability of society in that form of organization to realize otherwise existing potentialities. Under such real or apparent circumstances, man becomes a cannibalistic beast, and, in too many historical cases, a cannibal in fact.

The correlatives of the opposing views, the social versus the heteronomic individual, are historically the opposition of the Logos to the sensual. Social man locates his "soul," his personality in his membership in his society as a whole. He is in a state of *atonement* with the society as a whole. He acts for his society, realizes the rights afforded to his person by that society, and identifies himself morally as a person acting for his society as a whole. "My society has need of what I do for it, therefore my society meets its needs to fulfill my needs to maintain myself in that quality of function." The heteronomic man, the anarchist — the evil one — says, on the contrary, "Reality is my eating, my pleasure in sex, the gratification of my individual impulses as psychological needs. Nothing else is real to me."

The dull-witted fellow would therefore say that the first individual is an "idealist" and the second a "materialist." However, that dichotomy makes no sense except to the dull-witted. It is nothing but the mastery of the material conditions of life which is the immediate, mediating essential process on whose behalf the first outlook has developed. It reflects the fact that society can survive only by cooperative creative efforts to master natural law in practice. The heteronome denies that the material object of gratification is determined by natural law. In fact, it is the evil individual, the "atheistic-materialist" individual, the ignorant, savage frontiersman, who is the "idealist." It is he who places his arbitrary whims above natural law. two points of view is not a mootable difference of philosophical opinion. The former must be enhanced and the influence of the latter suppressed.

On this point Marx was emphatic. The working class ' in its ordinary, individualized, heteronomic condition is a mere class-in-itself, an object-class, a class of persons self-defined as mere bestialized objects. A class in such a condition is intellectually and morally incapable of adopting or even conceiving a positive historic purpose for itself for society in general. It is only the transformation of the pathetic "molecules" of the class-in-itself into a class-for-itself which creates thus in the working class so constituted a unique historic capability for defining a programmatic selfinterest in actual correspondence both with its own objective interests as a class and the general interests of society as a whole. It must be a class whose members have adopted the world outlook represented by Marx in the concluding paragraph of his 1835 Aufsatz.

The conscious self-interest of a working class as a class-for-itself is a program for fostering basic scientific research and the realization of the derived technologies through the use of social surplus to effect the simultaneous expansion and technological advancement of industry and agriculture. The continuing result of such a realized program is a continuing increase in the productive powers of labor, an increased technological power over nature which is uniquely the material basis for continuous advances in the culture of the members of the class and the class as a whole.

In other words, the basis for defining the conscious self-interests of the working class as a class-for-itself is exemplified by those economic plans of socialist countries which emphasize basic scientific progress, high rates of technologically advanced productive capital formation in industry and agriculture, and a matching advance in the education and materialcultural conditions of life of the population in general. No other sort of ideas are tolerable for identification as socialist ideas.

Idiot-socialists nonetheless conceive of socialism as "redistribution of existing wealth," and of placing themselves near the head of every procession of enraged jacqueries dedicated to looting the "more prosperous." Oh, the idiot-socialists profess themselves to be so very, very shrewd. "You see," they explain, "once we are inside the social ferment, we shall be able to spread socialist ideas." Hence, they join and incite a potentially fascist ferment in the hope that by becoming influential members in good standing in such sewage, they will lead these forces to socialism. Program? "No, that would only alienate the masses at this stage."

These distinctions in outlook are not merely ideas. The first outlook is essential to practical human survival. The second, if dominant, leads toward the extinction of societies. Hence, the difference between the

folly! It is precisely that evil rot which destroyed the old socialist organizations.

#### THE GUELPH DISEASE

Since the fight between the bestial Guelph faction and the humanist Hohenstaufen faction, the history of European civilization — and now of the entire world has been a continuous fight between the forces of bestialism (the Guelph faction and its heirs) and of humanism. The emergence of scientific socialism is but an included aspect of that overall and continuing struggle.

In point of fact, respecting capitalism itself, excepting the United States up to 1829 and for a brief period following the Lincoln administration, there has never been a capitalist republic established more than evanescently in any part of the world. So far, except in the socialist countries, the Guelph faction has predominated.

The humanist faction is not intrinsically either capitalist or socialist. The sixteenth through early nineteenth century humanists, the republicans, adopted capitalist political forms not to establish capitalism, but as the mediation of technological progress, itself the expression and mediation of the real object of humanism: a society in which man was perpetually self-perfecting. Humanism has always meant, whether in a capitalist or socialist context, the fostering of basic scientific discovery through technological development, which in turn provides the more advanced standpoint in conditions of life and culture for a further advance.

In an historic perspective socialism is necessary. The fact that capitalist political forms establish heteronomy in the ownership of the means of production and distribution means providing a foothold for the evil consequences of heteronomy in the most vital aspect of social life. This arrangement also alienates the productive powers of labor from the instruments through which labor fulfills its historic purpose. Hence, socialism is ultimately a crucial historic question, but is not in itself the most fundamental question. Humanism is. In the first emergence of the struggle for humanist republics, centering our attention for this purpose upon the sixteenth century in Florence and England and on the case of Erasmus himself, the definition of a republic meant a state committed to humanist principles, rather than the notions of democratic republican political forms as such. The state must be dedicated to the historic self-interests of the entire nation from the standpoint of technological, urbancentered progress and the education of its people. If the state was headed by a prince, this in itself might not be a defect in the republican form, on the condition that the prince himself was a self-consciously defined agent of the humanist principles of the state. Hence, Sir Thomas More's relationship to Henry VIII, and Thomas Gresham and Walter Raleigh's relationship to Queen Elizabeth. Hence, Niccolò Machiavelli's *The Prince*. Hence, Jean Bodin and the doctrine of the politiques. Hence, Colbert. Hence, the policies of Franklin's French Colbertiste allies toward the Bourbon monarchy.

The English Commonwealth, shortening the reign and height of the traitorous incumbent on the throne, effected the first important break with the notions of the monarchical republic. The influence of John Milton and other Commonwealth republicans on the settlers of the future United States, notably including Massachusetts and Pennsylvania. represented the circumstances in which the modern meaning of the term republic was first defined.

The population of the future United States was the most literate and cultured in the world. It had its loutish frontiersmen, but contrary to the Jacksonian bucolic myths, Jacksonian lies, the population of the American urban centers was at a qualitatively higher level of culture than any area of Europe. Under the leadership of one of the greatest minds in modern history, Benjamin Franklin, the potentialities of this, the world's most cultured population, a population steeped in republican humanist ideas from the Commonwealth experience, were hewn into the greatest force for political humanism the world had seen. It was not accomplished in an instant. Franklin was occupied for almost a century in creating and developing, almost piece-by-piece, the political machine which, in 1789, finally launched the approximation of that form of humanist republic which Franklin had devoted his life to building.

Who and what was Benjamin Franklin? What was Franklin doing in Italy, at Göttingen, in London, in Paris? Franklin was a scientist, who contributed significantly to the mastery of electricity, and who played a major part, in Italy, Germany, France, and England, in organizing for the mastery of this field in

particular. Franklin, the international organizer of scientific work, was also the world's greatest political figure of that period. He deepened the unity of the networks of humanists in England, where he selected his principal heir and assistant, Federalist Tom Paine. He early established himself as a leader among the Colbertistes of France, spread republican conceptions in Italy, and through his friends spread his direct influence into many parts of Germany. All of the greatest names in science of that period were directly or indirectly associated with Franklin and his humanist networks.

The fat, half-insane Mr. Guelph, heir of the faction that caused the bubonic plague, the Thirty Years War, and every other massive evil that Europe had known since the thirteenth century, through Pitt, Bentham, the Barings, and other scoundrels, succeeded in decapitating and routing the humanist industrialcapitalist movement which the then-deceased Franklin had been central in organizing. Civilization itself was sent reeling backwards into the nightmare that was the Holy Alliance.

Hence, Karl Marx, born in 1818, remained all of his life ignorant of those great events which had come to such a denouement within two decades before his birth.

But, evil did not prevail entirely. The Bach who the British nominalist scoundrels had attempted to make a nonperson in history was not, in fact "accidentally" discovered by Mendelssohn in the famous 1824 performance. Bach was not unknown in Europe; that legend is a not-so-cheerful fraud. Among the humanists, Bach was a battle cry. Beethoven was steeped in Bach, as well as the humanist influences dominating Bonn during his childhood and youth. Mozart, who became familiar with Bach later in life probably through humanist Illuminati circles seized Bach fiercely, his music leaping ahead by giant steps in quality as a result.

Although the humanist movement was crushed by the events of 1792-1815, Beethoven's music lived, as did Mozart's. Despite the unsuccessful efforts of the bestialists to brush Beethoven and the late Mozart aside, especially Beethoven, with the "new beginning" undertaken by the clever, passionless Mendelssohn and the wretched, degenerate Wagner, these greatest humanist forces in musical culture, Bach, Mozart, and Beethoven, persisted, unquenchable wherever music was actually heard.

Despite the efforts of the British-based nominalists to stamp out the influence of what they denounced as "continental" scientific epistemology, Pasteur, Weierstrass, Riemann, and Cantor persisted through their work. Despite his wicked, induced prejudices, Faraday could not help but contribute to validating "continental" humanist scientific currents, even with the aid of Maxwell's conscious frauds toward that end. Despite the vile Kronecker, Cantor's work survives. It took the British more than a century to stamp out French and German science, only to find the most advanced expression of these — e.g., Vernadsky building a new "continental" scientific force in the Soviet Union. Despite the crimes of the Solvay conference and Niels Bohr's hideous, paid complicity in the events of the 1920s on behalf of one more effort to crush "continental science," that humanist current in science is now erupting in many parts of the world once again.

History is not unilinear as Hegel wished it to be, nor even as simple as Marx deceived himself to regard it. However, the power of evil is also not as all-powerful as British monetarists attempted to make it.

Thus, the victory of the nominalists over Europe during 1792-1815 and over the United States in 1828 could eradicate consciousness of his forebears from Marx's mind, but did not prevent the humanist influences implanted in his home city, Trier, from defining his world outlook and identity for all his life.

Unaware of the existence or content of the humanist capitalist struggles of the eighteenth and preceding centuries, deluded that English capitalism was the "natural" model for capitalist development, Neoplatonic humanist Karl Marx undertook to rescue the historically progressive humanist principles from the capitalist decay he recognized England to represent. If this is capitalism, then it is time for socialism. So, in the face of the manifest "parliamentary cretinism" of the German capitalist republicans, Marx resurrected Neoplatonic humanism in the form of scientific socialism.

Then history played a cruel joke upon the conniving nominalists.

Anglo-Dutch agent Alexander Helphand-Parvus, placed as a British intelligence agent of influence within the Kaiser's intelligence, conducted what was to have been a major operation for carving up the Austro-Hungarian and Czarist Empires to the mutual advantage of Germany, England, and Holland, operating for this purpose with the British-controlled pacifist (intelligence) movement operating along the Scandinavian "Northern Route." In the tangles and toils of Parvus's schemings, he deemed it profitable to his purpose to have Lenin, then exiled in Switzerland, brought to Russia to add to the confusion. Accordingly, the German, Dutch, and British networks delivered Lenin and his party to Russia, depositing the sum of three million Reichsmarks into Parvus subagent Karl Radek's pocket to fund the festivities Parvus imagined would ensue.

Despite the insurance Parvus planted among the Bolsheviks in the persons of Karl Radek, N. Bukharin, Riazanov, and others, the Bolshevik revolution succeeded, and despite Bukharin's efforts, at the end of the 1920s belatedly launched its industrialization drive.


Now, Neoplatonic humanism has an armed bastion in the Warsaw Pact, a bastion too powerful to be eradicated. Soviet physics, best estimated to be two to four years in advance of the NATO countries in matters of momentous military potential, destroys forever the possibility of the nominalists' continuing their efforts to impose "zero growth" and related policies in the NATO and similar countries.

The Warsaw Pact is not going to invade Western Europe — unless some idiot provokes World War III. The present condition of the socialist organizations within the capitalist countries precludes a socialist transformation from within those nations for the forseeable future — barring protracted economic collapse or war. Nonetheless, the industrialized capitalist nations are going to have to finally reconcile themselves to living with socialist nations that cannot be crushed, and thus to bend to the humanist aspirations of developing nations for technologically vectored industrial development of industry and agriculture. Basic scientific résearch and its humanist realization must now begin to leap ahead once again.

Thus, through the outgrowth of Karl Marx's work, the Soviet Union most notably, a global circumstance has resulted in which, barring some insane idiot's provoking of general war, the entire world must adopt a Neoplatonic humanist policy. The industrially more advanced capitalist nations will continue to be capitalist nations, but they will be evolving rapidly into republics governed by Neoplatonic humanist principles.

In short, Karl Marx has turned out to be Benjamin -Franklin's revenge.



## I. History's Oldest Fraud

added nothing to his broader ethical or political goals, the future St. Paul defined the essential Christian attitude toward the Old Testament, as sharpened 1600 years later by John Milton, thusly:

God, dismayed by Adam's sin, realized that mankind in the early days following the Creation was still psychologically and morally a child, and like a child required firm discipline to keep its self-destructive and heteronomic impulses in check. This discipline God supplied in the form of the Mosaic commandments, a burden yes, but a necessary one. When mankind had matured, however, to the point of being able to successfully manage its affairs in accordance with the divine order, Christ redeemed Adam's sin, freeing humanity from obedience to the degrading positive laws of the Mosaic Torah, and making way for an order of human self-governance based on the rule of human reason. (3)

The fact is, however, that St. Paul and Philo and their successors who continued to pay considerable lip service to the Old Testament, did so only by suppressing its own actual content. As a result, those believers today upon whom it has not yet dawned that Paul, Philo, et al. never intended the Old Testament to be taken seriously but rather as a means to impress the credulous, are still forced to hysterically block out and deny or willfully distort what the Old Testament's theology and politics really are. (4)

In fact, the Mosaic tradition in the Old Testament is neither the inspired original statement of "modern monotheism," nor, as poor Theodor Herzl was deceived to argue, the historic foundation of Jewish nationalism. Rather, as examination of the origins of the Pentateuch in particular reveals, it is in the main a concoction of laws and "traditions" successively inspired by and evolved under the authority of the empires of Assyria, Nebuchadnezzar's Babylon, and Persia, for the precise purpose of suppressing the historic traditions which had governed the development of the historic Israelite and Judean kingdoms. Not only did the ancient Israelites not obey or, in most cases, even know the laws of the Pentateuch, but, as B. Spinoza pointed out, the very intent of these laws was to prevent formation of a healthy Israelite state. (5) As one notable example, the "Mosaic"

injunction to the Israelites to drive out and exterminate the Canaanites from Israel (6) is a vicious concoction which corresponds neither to the ethnic nor to the religious diversity which actually prevailed in the ancient states of Israel and Judah, nor either to their foreign policy conduct, which frequently found the two states allied with foreign powers against each other.

Moreover, contrary to the myth of "Israelite religious purity and isolation," the real religion of ancient Israel differed from the pagan worship of the rest of the ancient Near East in no essential principle, and this, ironically, is most emphatically the case with the very "Mosaic" tendency in Israel which professed to have the greatest religious differences with Israel's neighbors. The irony of the Mosaic Torah and associated biblical writings is that they arose in conscious opposition to the progressive tendency of thought - developed from Canaanite-Phoenician commercial culture by the Ionians and transmitted in bowdlerized form through Plato and later currents in the Hellenistic and Roman worlds — which came to dominate modern Judaism and Christianity through the work of Philo, St. Paul, et al.

The rigorous exposure of the fraud of the Old Testament is made possible by two developments in modern study of ancient history: first, the decipherment over the past 100 years of the cuneiform and hieroglyphic records of the ancient Near Eastern peoples and the Egyptians, which has yielded contemporary (if not always accurate) records of events synchronous with and in many cases directly linked to events reported in the Old Testament. This has furnished an accurate historical overview for the history of the Near East into which virtually all of the major figures and events of the Old Testament — those, at least, who really existed — can be accurately fitted, some events being datable even to the day. Secondly, textual analysis of the Old Testament, inspired to a significant degree by Spinoza's 1670 Tractatus Theologico-Politicus, has sorted out the maze of contradictions and factual confusion that permeates the Old Testament, particularly the Pentateuch, and, in the case of the "Mosaic" Pentateuch, and, documented that at least four basic source documents.

written at considerably differing periods, have been artfully combined to yield the five biblical books that the gullible still attribute to "Moses."

The results of the following study are based on a comprehensive gridding of the biblical sources against the contemporary historical developments in both the Near East and the Mediterranean world, particularly Phoenicia and Ionia.

The most significant points of departure are the period of David and Solomon, which saw the actual formation of the Israelite state and people under Phoenician guidance; the period of the Ionian Homeric poems, the mid-eighth century BC, which say the beginnings of the Ionian colonial movement; and the period of the high-point of Ionian scientific and philosophical development a century and a half later, the period just prior to the Persian conquest of Ionia which saw the flourishing of Thales, Anaximander, Solon, et al.


To the time of the Homeridae belong the prophets Amos, Hosea, and Isaiah, who had before them the even earlier story of Adam's Fall from Genesis. Contemporary with Thales and Anaximander are (roughly) Jeremiah, Ezekiel, the Second Isaiah, and the creation account of Genesis.

It is the story of Adam's Fall which is the earliest developed expression of the characteristic, reactionary outlook of the Old Testament, which existed only as a minority viewpoint in the period of Isaiah, in opposition to the outward-looking, prodevelopment policy-orientation of the Phoenicians and their Israelite allies. It was not until the time of Jeremiah and Ezekiel — paid agents of Nebuchadnezzar of Babylon — and of the anonymous "Second Isaiah," an agent of Cyrus of Persia — after most of the Israelite nation had been dispersed through the successive deportations of the Assyrians and Babylonians — that this outlook began to be forcibly imposed on the unwilling remnant of the Judeans.

The whole concoction reached its final form — the basic Pentateuch — due to the work of Ezra and his associates, operating in the fifth century BC under orders from the Persian government. Measured against the Ionian achievement, the result, the religion of the Old Testament, the Torah of "Moses," is, as Milton perceived, one of the last of the ancient pagan religions, and in no sense a precursor of Christianity or modern Judaism.

### **II.** The Plot Against Prometheus

The humanists of the Renaissance recognized — and were perplexed by — the fact that Adam of Genesis is really the same person as the Greek titan Prometheus ("Forethought"), a fact which forced them to

somehow confront the fact that the Genesis story as it appeared in the Sacred Books was a vitriolic attack on everything humanism stands for.

There were two myths of Prometheus in antiquity, one adopted by Aeschylus, Plato in his dialogue *Protagoras*, and other proponents of progress, the other version an anti-Promethean diatribe circulated not only by the author of Genesis 3 but by the reactionary Greek poet Hesiod as well.

For Plato, Aeschylus, and other protohumanists throughout the first millenium BC, Prometheus was the symbol of the great movement of technological innovation, commercial expansion, and scientific investigation which, in the form it achieved in its culmination in Ionian philosophy and science in the sixth and fifth centuries BC, gave mankind its decisive push toward modern humanist culture. In myth, it was the titan Prometheus who stole fire from Zeus — the ancient sky-god representing in the humanist version of the Prometheus myth the most reactionary aspect of Greek culture — and bestowed on man that creativity and capacity for technology which separates him from animals.

The Promethean movement began not in Ionia but in the cities of the Phoenicians: the biblical Canaanites (as they termed themselves in their own language) or Sidonians. The Phoenician cities had begun to exercise a systematic civilizing impact over their rude Israelite and other neighbors as early as 1000 BC — the circumstances and details of which we shall consider below — and around the end of the ninth century BC they began to carry their trade and technology outward into the Mediterranean, coming into contact with the then still-primitive and barbarian Greeks.

The Phoenicians brought with them the major technological innovation of using iron for peaceful pursuits (1000 BC is the approximate dividing line between the "Bronze Age" and the "Iron Age"), the products and skill of the metalworker, the technology of textile dyeing and manufacture (later to play a role in the development of the leading Ionian city, Miletus), and with these the alphabet — the Greeks had hitherto been illiterate — and the beginnings of abstract scientific and philosophical speculation.

Fragments of an early Phoenician universal history preserved in a much later Greek translation by the Christian bishop and associate of Constantine, Eusebius of Caesarea, indicate the protoscientific character of the Phoenicians' development and the orientation of their policies in this period toward technological progress. (7)

Eusebius's excerpts from the Phoenician document begin with his narration of the Phoenician account of the origin of the world:

The principle (*arche*) of the whole he posits as darkened air and exhalations or vapors of darkened air and foul, dark chaos. And these are infinite and on account of their great age have no limit. "But when," he says, "the wind (pneuma) fell in love with its own causes (archai), and mixing began, that combining was called desire. And this is the principle of creation of all things. And from the combination of it with the wind there was born Mot. This some call mud, but others a putrefied sludge of aqueous mixture. And from that was born the whole seed of creation and the coming-to-be of the universe. And there were some living things which did not have perception, and from them were born intellectual living things. And they were called Zophasemin, that is, the overseers of heaven. And it was likewise formed with the shape of an egg. And Mot shown forth, both sun and moon and lesser stars and greater stars."

It proceeds to a rationalistic account of the origin of life, based upon natural processes:

"And when the air shown thoroughly, through the inflammation of both sea and earth there came to be winds and clouds and very great downpourings of heavenly waters and floods. And when everything was divided and separated from its own place by the fire of the sun, and then afterwards all came together in the air and were dashed together, thunder and lightning were produced; and in consequence of the thunder, the intellectual living things spoken of awoke, and were frightened by the noise, and both male and female moved on earth and in the sea."

Finally, the Phoenician account of the origin and development of civilization is centered on the advance of technological progress:

... the next mortal generation, whose names were Light, Fire, and Flame... discovered fire made from the rubbing together of wood, and taught its use.... Hypsouranios founded Tyre and invented huts made from corn stalks, rushes, and papyrus.... Long after the generation of Hypsouranios, Agreus and Halieus were born, and they discovered hunting and fishing, and from them huntsmen and fishermen were named. From them were born two brothers, the discoverers of iron and the working of it....

It was these predicates of social progress which among the Greeks were mythically attributed to the genius of Prometheus. (8)

#### The Phoenicians and the Greeks

The impact of the literate culture and the trade and industry of the Phoenicians caused a profound change in the Greeks' modes of thinking, beginning in the mid-

eighth century BC. Prior to their contact with the Phoenicians, the Greeks had sunk to a level in many respects only somewhat higher than that of the late Stone Age Indians who greeted the Pilgrims — as the evidence of the primitive Greek "geometric" pottery conceptually akin to the products of the U.S. southwest Indians (particularly after the Indians' contact with Europeans) and the abundant traces of totemistic practices among the Greeks attest. (9)

The Greeks' social organization was dominated by a primitive tribe-phratry-clan structure which possessed all the barbaric and superstitious religious rituals, fetishes, taboos, totems, and narrowness and immorality of outlook characteristic of such structures. As the U.S. Founding Fathers were later to recognize apropos of the American Indians, such social structures are an absolute obstacle to commercial and technological progress.

Under the impact of the vastly more advanced Phoenician commercial culture, early Hellenic **Prometheans systematically defined and attacked the** ideological characteristics of this primitive Greek system, in terms of the best features of Iron Age Mediterranean civilization of the ninth and eighth centuries BC. The record of their effort survives in the two great Homeric epics, the *Iliad* and *Odyssey*, which were written down in Ionia around 750 BC (Iliad) and 725 BC (Odyssey), not long after the Phoenician alphabet was adapted to express the Greek language. In defining the requirements imposed on their contemporaries by the challenge of international commerce and exploration, the Homeric poets created a polemic on behalf of the powers and superiority of the human mind which rightfully earned their poems their status as the first surviving works of modern literature,

The Iliad focuses on the qualities of leadership which the narrow-minded Greek tribal chieftains had to acquire in order to effectively lead commercial and colonizing expeditions of the sort them being conducted by the Phoenicians. Taking as his basic subject matter episodes from the epic cycle of the Trojan War which had evolved over several centuries mainly to exalt the piratical and plundering skills of the Greek clan leaders, the poet ironically restructured the material around the story of what happened when as was no doubt frequently the case among Greek chieftains of the time — the leading figures in the Trojan expedition disgrace themselves in a quarrel over the distribution of concubines taken in pirate raids in the vicinity of Troy which both violated pre-

vailing moral standards and had nothing to do with the ostensible aim of the expedition. Not only, the poet shows, does their conduct bring the entire operation before Troy (which he treats symbolically as a social aim around which all the Greeks have united, an achievement long sought but never attained by later humanists of Greek antiquity) grinding to a halt and the brink of failure. The two leaders, Agamemnon and Achilles, nearly provoke the dissolution of the united Greek force in a childish name-calling session before a council of the Greek chiefs. From this point, the main theme of the poem 'revolves around the political organizing efforts of Odysseus and a few others possessing appropriate qualities of outlook to drum a minimal quantity of social responsibility and self-discipline into the heads of the two protagonists, whose deficiencies in these areas no doubt typified the general qualities of most of the Hellenic leaders of Homer's time (and many since).

The subject of the slightly later Odyssey is the nature of the mental qualities required to conduct the type of trading expeditions already being carried out in the eighth century BC by the Phoenicians. The poet structures his epic around a series of common folk tales, told by Greek mothers and other mothers throughout Europe to their children to foster the conviction that the world outside the confines of the clan and its fetishes was too threatening to risk entering. Addressing himself to the psychological difficulties faced by Greeks who had been subjected to such conditioning when they were subsequently called upon to join the burgeoning trading and colonial expeditions, the poet contrasted the response of the undisciplined and hysterical individual (represented by Odysseus's crew) and the creative and selfconscious individual (Odysseus) to the challenging and unfamiliar circumstances of long sea voyages. The object lesson is that the crew perish to the man through their own folly, while Odysseus, the man "of many ways" who "learned of the minds of many men," survives. (10)

This Promethean outlook produced far-reaching consequences in the sphere of religion which were for the most part only implicitly foreshadowed in the levity and irreverence with which the Homeridae treated the myths surrounding the Olympian gods. Prior to the first millenium BC, the civilizations of the Mediterranean world made no clear distinction between the processes that govern nature and such processes of human thought and action as they knew empirically from their own internal experience. Natural

events were thus attributed to the actions of a plethora of gods, daimones, and numina, who were furthermore presumed to think and act with all the bestiality, vindictiveness, and greed which also characterized much of the human population of those days. The behavior of these supposed intelligences, and of the often wealthy priests who ministered at their sanctuaries, was "regulated" by a system of organized ritual propitiation — the bestowing upon them of gifts, in the form of sacrifices and other offerings, by their devotees. Propitiatory worship by means of offerings was universal throughout Mesopotamia, Palestine, Syria, and the Hellenic world, and regulations governing offerings form a major part of the "Mosaic" Law of the Old Testament.

Proceeding on the basis of the trade-anddevelopment-oriented worldview bequeathed by the Phoenicians and their Homeric forebears, the Ionians in the sixth century BC for the first time rigorously described the workings of the universe in terms of natural processes which operate in a manner that is both consistent with and yet distinct from human mentation, which the most advanced Ionian thinkers recognized as the highest order of natural processes. As a result of this achievement, the Ionians not only exposed the entire, sacrifice-based religious and social outlook of their contemporaries as useless superstition, but, by distinguishing unique characteristics of the human mind, opened the way to the first scientific investigations into epistemology and the laws governing human society.

Despite the fact that it was nearly a thousand years before the last vestiges of paganism were eliminated in the Mediterranean world, it was Ionian science of the mid-first millenium BC which dealt paganism's death blow.

From its beginnings, the progress of Phoenicianbased trade and commerce encountered opposition. In Palestine, the rustic backwater of Canaanite civilization lacking its own direct access to the Mediterranean, the Phoenicians' opponents coalesced around the school of thought identified with the biblical prophets. In the Greek world, the same ten-

Himself a participant in Kyme's overseas activities, Hesiod's father developed "cold feet" according to the poet, and repaired to Boeotia to farm — hence the fact that the poet dency formed, towards the end of the eighth century BC, around the writings of the reactionary Boeotian poet Hesiod. In his two principal surviving works, the *Theogony* and *Works and Days*, Hesiod, drawing on currents of reaction already well developed in the Near East, delivered blasts at trade, commerce, and above all Prometheus, in a story derived from the same source as the biblical story of Adam ("man"). (11)

Hesiod's argument against Prometheus was twofold: first, the simple claim — as object lesson that Zeus had horribly punished Prometheus for his hubris in the theft of fire; and second — the parallel with Genesis - that Prometheus's deed, the giving of the capacity for skilled labor to man, was responsible for what Hesiod viewed as the current wretched condition of mankind. In an account substantially identical to the biblical story of man's origin in the idyllic "Garden of Eden," Hesiod claimed that the first men had lived in a blissful age of "gold," that this had degenerated to a slightly less blissful "age of silver," but that as a result of Prometheus's deed, the men of his day were forced to live in an age of "iron," characterized by the need to perform labor as the condition for survival. "For the gods," he claimed,

keep hidden from man the means of life.... Zeus, in the anger of his heart hid it, because Prometheus the crafty deceived him; therefore he planned sorrow and mischief against men. He hid fire; but that the noble son of Iapetus (Prometheus — PA) stole again for men from Zeus the counsellor in a hollow fennel-stalk, so that Zeus, who delights in thunder did not see it. But afterwards Zeus who gathers the clouds said to him in anger:

"Son of Iapetus, surpassing all in cunning, you are glad that you have outwitted me and stolen fire — a great plague to you yourself and to men that shall be. But I will give men as the price for fire an evil thing in which they may all be glad of heart while they embrace their own destruction." (12)

found himself in Boeotia. Even so, Hesiod was hardly removed from urban civilization: as he himself relates, he maintained contacts in Chalcis, a city on the island of Euboea which was one of the leading Greek colonizing cities in the period of Hesiod's lifetime. Moreover, ordinary peasants in the eighth century BC were even less likely to publish books than today. All copies were reproduced by hand and were priced accordingly. Therefore Hesiod was a mouthpiece for reactionary political factions in Chalcis. As is discussed below, similar considerations can be profitably applied to the writings of the prophet Amos in Judah, whose professions of being a simple but rigidly moralistic shepherd are often taken far too seriously.

As in the Garden of Eden myth, this "evil thing" is woman — Pandora, the Greek Eve — who, Hesiod claims, unleashed diseases, sickness, and hard work on men. "For ere this," the poet, an avowed misogynist and zero-growth advocate, says, "the tribes of men lived on earth remote and free from ills and hard toil and heavy sickness." (13)

His close relation to Hesiod is sufficient to establish the author of the Genesis "Fall" story as standing squarely on the side of those ancients opposed to the Phoenician-originated movement of trade and progress in the early Iron Age, and it is the "Fall" story that establishes the monotonous schema of sin and divine punishment that runs through the earlier books of the Old Testament.

# III. Israel in the Land of Canaan


The irony of the Old Testament's anticommercial outlook is that ancient Israelite civilization was originally a product of the same Phoenician commercial culture that initiated the development of Ionian Greece, and developed as a result of a struggle to overcome precisely the backwardness for which the prophets stood. In fact, close association with the Phoenician trading cities, principally Sidon and Tyre, is the invariant characteristic of the high points of ancient Israelite culture. The view embodied in the story of the Fall is alien to the original constitution of the Israelite state.

It is one of the frauds of the Old Testament that one Moses led the Israelites out of Egypt and to the border of Palestine, and enjoined them not to mix with the local inhabitants (the Canaanites, etc.) but instead to exterminate them and to jealously guard their own racial purity and religious institutions — which he had provided for them as per a series of mountain-top meetings and conversations with the Deity. The story that his successor Joshua then led the united twelve tribes of the Israelites across the Jordan River into Palestine and to a succession of miraculous (literally) victories over the existing inhabitants, divided Palestine among the tribes, etc., compounds the fraud.

While it is possible that Moses existed, the only conclusion that can be securely reached about his hypothetical personal role in Israelite history is that it was distorted — in the direction of gross amplification

— beyond possible reconstruction in the centuries following the purported date of his "death." (14)

More likely, the Israelites entered Palestine as a series of disorganized and disunited tribes in the period around 1400-1200 BC. (15) This was a time of rapid social decay pervading the entire Mediterranean and Near Eastern world, which culminated around 1188 BC when a diverse horde originating mainly in the Aegean and Mediterranean area (called the "Sea Peoples" in the brief Egyptian account which reports their activity) swept across Asia Minor and down the Palestine-Syrian coast to the border of Egypt. The Sea Peoples raid was comparable in its trauma and effects to the impact of the Black Death on medieval Europe: The great cities of Asia Minor and northern Syria were destroyed, the empire of the Hittites was annihilated and the Hittites restricted to a string of cities in Cappadocia and northern Syria, Egyptian power was pushed back to the Sinai, and social chaos reigned in Palestine.

Like the Renaissance following the Black Death, the revival of Mediterranean civilization following the Sea Peoples' raid was based on a qualitative advancement in human civilization. In the period under consideration, the basis of this advance was the introduction of iron for widespread use in agriculture and manufacturing, and the men who initiated it were the inhabitants of the Phoenician cities in what is today Lebanon.

In the Late Bronze Age, Phoenicia and northern Syria (the meeting place of the Hittite and Egyptian Empires) had been thriving centers of Mediterranean-wide trade and a highly cosmopolitan civilization, which had already solved the challenge posed by an influx of merchants speaking numerous different languages by inventing the modern alphabetic system of consonants. (16) While much of this civilization was destroyed by the Sea Peoples, the remaining Phoenician cities — principally Sidon, Tyre, and Byblos — still possessed strongly estab-

Most importantly, the Phoenicians made a conscious, factional decision to foster the development of iron tools, which first found significant productive use in Palestine around the beginning of the first millenium BC. This decision was prompted by a twofold political problem which the Phoenician cities faced. On the one hand, tribes of herdsmen had invaded Palestine and the Phoenician hinterlands which would later be amalgamated into "Israel" creating serious disruptions, the nature of which is sufficiently indicated in the Book of Judges. (18) Secondly, several groups of Sea Peoples, principally the Philistines, had settled along the Palestine coast, and were engaged in piracy and similar activities which disrupted Phoenician trade both overland and by sea. (19)

The Phoenicians' solution to this situation was conditioned by the fact that, in addition to their brigandage, the Philistines had created enormous resentment among the Israelites by imposing a policy of enforced backwardness based on the restriction of tools for the Israelites. (While the citing of biblical chapter and verse apropos of current events is a risky business, in this case there seems to be a clear object lesson for the architects of the Carter Administration's unhappy policy of restricting export of nuclear technology.) I Samuel 13:19 reports:

Now there was no smith to be found throughout all the land of Israel; for the Philistines said, "Lest the Hebrews make themselves swords or spears"; but every one of the Israelites went down to the Philistines to sharpen his plowshare, his mattock, his axe, or his sickle.

The Phoenicians, on the other hand, pursued a policy of fostering trade and commerce in Palestine. At an early date, the Canaanites in Palestine had be-

come heavily intermingled with the Israelite newcomers (20) and even appear to have coopted some of the Israelite groups into their commercial enterprises. (21)

It was this fight, Phoenician trade versus Philistine backwardness, that was the issue in the war fought by Saul and David, in which Saul was allied with the Phoenicians (22) and in which David, initially employed as a countergang leader by the Philistines against Saul, (23) was persuaded (probably through association with Abner's followers) to make association with the Phoenicians and to adopt the principles of their outlook as the principles of his state. (24)

In any case, by the close of his reign, David's prosperous kingdom was aligned with the celebrated King Hiram of the leading Phoenician city, Tyre, and the contested Israelite succession was secured by a son, Solomon, committed to continuing that association.

Of this Hiram, it is recorded by both Greek historians and the Bible that he was a great builder and innovator. The Greek source reports that

He erected the Eurychoron (a broad plaza in Tyre between the city and the temple of the chief Phoenician god, Ball Samin — PA) and set up the gold pillar in the temple of Zeus (Baal Samin — PA). Having gone for timber, he cut cedar wood from the mountains called the Lebanon for the temples of the sacred rites, and he tore down ancient temples and built new ones, both the temple of Herakles and the temple of Astarte, and he was the first to make the awakening of Herakles in the month of Peritios. He sent an expedition against the Uticans (the location and exact name of the city referred to are unknown — PA) who had refused to pay their tribute, and having subjected them

The Old Testament relates that Hiram was the contractor who built the celebrated temple of Solomon in Jerusalem — the "first" temple destroyed in 586 BC by Nebuchadnezzar of Babylon — supplying both timber and skilled craftsmen for the task. (26) The Old Testament also reports that Hiram engaged in joint trading ventures with Solomon, supplying crews for trading ships of Solomon's which sailed from the Israelite port of Ezion-geber on the Gulf of Aqaba. (27)

Solomon himself rebuilt numerous ruined cities throughout his kingdom, and made considerable improvements in Jerusalem as well. As a center of trade, his kingdom was highly cosmopolitan. Solomonic Israel was tolerant of a multitude of religious cults, and, in accordance with the common diplomatic practice of the period, the king maintained his sizeable, celebrated *seraglio*, reportedly including daughters of the kings of Egypt and Tyre.

After Solomon's kingdom split in two and went into a period of decline after his death (around 930 BC), the fortunes of Israel, the northern kingdom, were revived by the dynasty of another celebrated king, Omri (reigned c. 873-869 BC and possibly of Arab ancestry), who also made collaboration with the Phoenicians and adoption of Phoenician culture and commercial practices the cornerstone of his policies. Omri's influence was sufficient that for more than a century after his death Israel was referred to in Assyrian documents as "Omri-land." Even more important was his son, Ahab (reigned approximately 869-850 BC), the scope of whose building projects exceeded even those of Solomon.

the "LORD" in translations of the Old Testament), later introduced as the "holy of holies" at the central sanctuary in Jerusalem by David and Solomon, was actually banished to the Gibeonite (non-Israelite) town of Kiriath-jearim. Omri came to power at the same time as a vigorous new king of Tyre, Ithobaal, (28) and the two kings clearly patterned their relations and policies on those of Hiram and Solomon. Omri built a new Israelite capital city, Samaria (whence the name "Samaritans"), while Greek historians credit Ithobaal with founding new cities in Phoenicia and Africa. (29)

Archaeological results have confirmed biblical indications that Ahab made vast improvements in Israelite cities. (30) Not only, it turns out, was his celebrated "house of ivory" furnished with Phoenician ivories, but further evidence of Israelite-Phoenician cooperation in his urbanization program is provided by the numerous examples from Israelite buildings of the period of the Phoenician-styled "proto-Ionic" or "proto-Aeolic" capitals which several hundred years later evolved into the classic Greek Ionic style.

To cement ties between Samaria and Tyre, Ithobaal and Omri arranged a marriage between Ahab and one of Ithobaal's daughters, the widely slandered Jezebel. Ahab himself sent one of his and Jezebel's daughters, Athaliah, to be married to the king of Judah, the southern of the two kingdoms, drawing this state into the general prosperity.

## IV. Assyria and Reaction

Despite the manifest progress made in their reigns, the Old Testament remembers both Solomon and Omri and Ahab most for apostasy and the dilution of "Israelite" culture, coupled, in the case of the latter two kings, with allegations of commercial corruption.

Solomon's accomplishments in urbanizing his kingdom and building up its wealth and trade, and in erecting the very temple of Yahweh in Jerusalem, are overridden, in the Old Testament's evaluation of his reign, by his sins of taking foreign wives (polygamy, of course, is sanctioned by the Old Testament) and of permitting the worship of cults other than that of Yahweh. "For Solomon went after Ashtoreth the goddess of the Sidonians, and after Milcom the abomination of the Ammonites," I Kings 11:5 pronounces. "Solomon did what was evil in the sight of Yahweh, and did not wholly follow Yahweh."

The biblical censure of Solomon is mild in contrast to the frenzy of slander and imprecation directed against Omri, and especially against Ahab and Jezebel. Ahab is singled out for murdering to acquire property and for erecting a temple of Baal (the Tyrian

city-god Melcarth or Tyrian Herakles) in Samaria, although this facet of Tyrian culture was certainly an advance over the bedouin-oriented system of worship centered around two golden calves which had been instituted in Israel following the break-up of Solomon's kingdom. Jezebel is damned for everything from murdering prophets to wearing make-up.

The key to the Old Testament's attitude lies not in Israel, but in developments in Mesopotamia.

The beginnings of the reigns of Ithobaal in Tyre and Omri in Israel coincided with the revival of the power of the Mesopotamian kingdom of Assyria, the third major factor, along with Egypt and Phoenicia, in the politics of the biblical world.

A lie circulated in many ancient-history books maintains that the development of imperial Assyrian power, which was eventually to embrace Syria, Phoenicia, Palestine, and Egypt, and its organic successors, the Neo-Babylonian and Persian empires, contributed, through the establishment of law and order and centralized government over a wide area, to promote the spread of civilization and particularly of trade during the time of biblical Israel. Nothing is further from the truth.

It is true that Assyria (upper Mesopotamia) and Babylonia (lower Mesopotamia) had played a major pioneering role in the development of trade and commerce in the Mediterranean and Near Eastern world some thousand years prior to the period of biblical Israel. At that time, such a policy had been designed to compensate for the fact that Mesopotamia is severely lacking in both metals and wood, and the ancient Mesopotamian states depended on the Lebanon for timber and on Asia Minor and Armenia for metals. In this earlier period, Mesopotamians had acquired these necessities through trade, but the process of collapse of the Bronze Age commercial networks, which culminated in the Sea Peoples raids, had left both Babylon and Assyria isolated and prostrate, and saddled with a social structure - especially in Babylonia — based on entrenched priesthoods with extensive interests in feudal-like temple estates.

As they evolved in the course of the first millenium BC, the Assyrian and Babylonian social structures increasingly generated large numbers of slaves, and corresponding shortages of skilled labor. The

Assyrians in particular developed a system of agriculture and land speculation in which slaves were bought and sold with the plot of land they occupied. (31)

To meet their requirements for skilled labor and industrial products, the Assyrians and Babylonians, and the Persians after them, adopted a conscious policy of looting the populations and possessions of their neighbors, beginning in the early ninth century BC. (32)

The first of the evil Assyrian conquerers was Ashurnasirpal II (883-859 BC). Extracts from his inscriptions illustrate the character of his activity:

The tribute of the kings of the seacoast, of the people of Tyre, Sidon, Gebail (Byblos), Malhata, Maisa, Kaisa, Amurru, and Arvad, which lies in the midst of the sea, — silver, gold, lead, copper, vessels of copper, garments made of brightly colored wool, linen garments, a great *pagutu* and a small *pagutu*, maple-wood, boxwood, and ivory, and a dolphin ("sea-horse"), a creature of the sea, I received as tribute from them, and they embraced my feet. Into Mount Amanus I climbed up, and beams of cedar, cypress, juniper, and pine I cut down. (33)

The former city of Calah ... I built anew, peoples whom my hand had conquered, from the lands which I had subdued, from the land of Suhi, from the land of Lakê, in its entirety, from the city of Sirku on the other side of the Euphrates, from the land of Zamua to its farthest border, from Bît-Adini and the land of Hatte, and of Liburna of the land of Hattini I took and I settled therein. ... (34)

Feudal dues, forced labor, and overseers I imposed upon the land of Nairi. (35)

I cut off their heads, I burned them with fire, a pile of living men and of heads over against the city gate I set up, men I impaled on stakes, the • city I destroyed and devastated, I turned it into mounds and ruins heaps, the young men and maidens in the fire I burned. (36)

The appearance of Ashurnasirpal II in Syria and Phoenicia in 876 at the head of an army to gather tribute forced the Phoenicians and their commercial allies — both the Israelites and the important Ara-

maean and Neo-Hittite cities of Syria — to consider how to deal politically with the Assyrian threat. The Phoenicians adopted the same strategy they had earlier applied to the Israelites: conquer them with trade, backed, where necessary and possible, by judicious resistance by armed force. (37)

These efforts seem to have had effect. From the period of his first invasion of Phoenicia in 876 down to his death in 859 BC, Ashurnasirpal made no more major sorties against the Phoenicians, and an inscription from late in his reign records that the Tyrians and Sidonians were among those who sent emissaries to be present for the dedication banquet of his new palace at Calah. (38)

The next Assyrian king, Shalmaneser III, however, dumped his late father's principal advisors immediately on succeeding to the throne and embarked on renewed military operations against the Aramaeans and Israel. In 853 BC, Shalmaneser invaded Syria, and it was at this time that Ahab's skill in dealing with the Assyrians was made manifest, in an episode which has been blacked out of the biblical account of his reign. Despite the reported disruptive efforts of the prophets Elijah and Elisha, Ahab had, through much difficulty and delicate diplomacy, reached a modus vivendi with Israel's old and powerful northern antagonist, Damascus. (39) The consequence was that when Shalmaneser's forces marched into Syria, they were met by a powerful coalition of Aramaean forces at Qarqara on the Orontes River, which included a contingent of Ahab's forces numbering 2,000 chariots and 10,000 foot, sizeable enough for the Assyrians to place the Israelites third in their list of the enemy order of battle. (40) While Shalmaneser claimed that he won a crushing victory in the ensuing battle, the fact that his army conducted no more operations in the area has led most scholars to conclude that he suffered a humiliating check.

Although no direct positive evidence has survived, it is not difficult to conclude that Shalmaneser had a hand in the internal subversion in Israel, centered around the prophets Elijah and Elisha, which culminated some ten years after Ahab's death in a brutal coup d'état against his successors. There is no "smoking gun" to seal the case (as there is in the case of the prophet Jeremiah), but Shalmaneser was the principal beneficiary of Elijah and Elisha's work. What characterized the two prophets was violent

opposition to the commerce-oriented elements of Phoenician culture which had come to dominate Israel, this opposition reflected not only in their attacks on "Baal" worship but also in such stories as the tale of the "widow's oil" (II Kings 4:1-7) which attacks the alleged rapacity of the Canaanite business world. Rightly did Ahab term Elijah — whose sedition he battled for years — the "troubler of Israel." In 842 BC, after Ahab's death, an officer named Jehu staged a successful coup against Jezebel and Ahab's son ruling in Samaria. At the same time Jehu murdered the reigning king of Judah — who was married to Ahab's daughter Athaliah — but timely counteraction by this resourceful queen in Jerusalem prevented him from seizing power there too. (41)

Putting the political principles enunciated by Elijah into effect, Jehu ended Israel's alliance with the Phoenicians and moved to extirpate the influence of Phoenician culture on Israel. He based his power on a Yahwistic religious sect calling itself the Rechabites. (42) The principles of this sect, as articulated by its founder Jonadab b. Rechab to his followers, were

to drink no wine all our days, ourselves, our wives, our sons, or our daughters, and not to build houses to dwell in. We have no vineyard or field or seed; but we have lived in tents, and have obeyed and done all that Jonadab our father commanded us. (43)

The other significant policies adopted by Jehu were the immediate payment of tribute to Shalmaneser, reversing the policy of Ahab on this account, and related both to his subservience to Assyria and his opposition to technology — the dismantling of the powerful military machine built by Ahab. By the time of Jehoahaz, Jehu's son and successor, the Bible reports that "there was not left . . . an army of more than fifty horsemen and ten chariots." (44)

#### Jehu and Genesis

There are strikingly close parallels between the activity associated with Jehu, and the Genesis story of

Adam's Fall, parallels so close that a leading twentieth century German biblical scholar, Otto Eissfeldt, was led to conclude — in the most cautious statement of the case — that the seizure of power by Jehu and the movement around Elijah and Elisha provided the "soil" around which the Fall myth "grew." (45)

This is not to say that the entire Pentateuch (Genesis through Deuteronomy) is a product of the forces associated with Jehu. Beginning in the eighteenth century, scholars began to distinguish what proved to be several separate narrative documents which have been homogenized and digested into the present Pentateuch. Since the late nineteenth century, there has been broad agreement among all but the most bitter fundamentalist and talmudic die-hards that these basic documents are four: "J," or the "Jehovist" document, "E," the "Elohist" document, the Deuteronomic Code (D), and the Priestly Code (P), written in that order over a period spanning the ninth through fifth centuries BC (the earliest thus written 400 years after the purported date for "Moses"!), plus miscellaneous legal codes and a substantial quantity of redactional material added to reconcile, combine, or supplement the various sources. (46)

Despite often wild divergences in matters of detail, the various documents are in agreement in propounding a fantastic and demonstrably spurious reconstruction of Israel's history which maximizes Israel's historic and cultural connections to Mesopotamia, and minimizes or slanders those with Phoenicia and Egypt (which, at the time of Jehu, was ineffectually supporting the Phoenicians against Shalmaneser, and which continued to oppose the activities of the Assyrians and Babylonians throughout the formative period of the Pentateuch).

The Adam story is contained in what is commonly termed the J story of the creation. (47) The parallel which links the Adam story with Jehu — in addition to the general hatred of progress and intellectuality identified above — is the bedouin-oriented opposition to agriculture common to both the Adam story and the Rechabite sect. In the Adam myth, this opposition emerges in the "punishment" meted out by Yahweh to

Adam and Eve after he discovers that the pair have acquired knowledge: Mankind is "condemned" to practice agriculture, which one might otherwise regard as an important advance over the fruitgathering existence depicted in the Garden of Eden. In the words of Genesis:

And to Adam he (Yahweh – PA) said,

"Because you have listened to the voice

of your wife,

and have eaten of the tree

of which I commanded you,

'You shall not eat of it,'

cursed is the ground because of you;

in toil you shall eat of it all the days of your life;

thorns and thistles it shall bring forth to you;

and you shall eat the plants of the field.

In the sweat of your face you shall eat bread

till you return to the ground,

for out of it you were taken;

you are dust,

and to dust you shall return. (48)

Proceeding to chapter 4 of Genesis, still within the J stratum, we learn that Cain murdered his brother Abel from pique over the fact that, Abel being a "keeper of sheep" and Cain a "tiller of the ground," Yahweh preferred Abel's sacrifices — offerings of meat — to Cain's offerings of grain, for which Yahweh "had no regard." Cain's punishment for murdering his brother is still another curse on the land: "When you till the ground, it shall no longer yield to you its strength; you shall be a fugitive and a wanderer on the earth." (49)

In the realm of social science, the early Pentateuchal source places the origins of civilization in Babylonia (the "land of Shinar" of Genesis 11), and may have included the puzzling reference to Abraham's origins in "Ur of the Chaldeans" — also in Babylonia.

Whether early in the development of the Pentateuch (ninth century BC) or late (sixth or fifth century BC), this "Ur of the Chaldeans" reference bears the odor of a politically motivated fabrication. Although Ur was indeed a very ancient city — as has been made much of by defenders of the historical verisimilitude of the Bible — prominent in Sumerian times in the third millenium BC, the Chaldeans had no presence in Ur in the purported period of Abraham, the mid-second millenium BC (this fact usually receives less attention in standard commentaries). The Chaldeans were active in southern Mesopotamia, however, in the period of Shalmaneser and Jehu, when some apparently helped to prop up the Babylonian end of Shalmaneser's operations. (50) During the period of Babylonian agent Jeremiah and the subsequent Judean exile to Babylonia, in the sixth century BC, the Chaldean dynasty of Nebuchadnezzar occupied the throne of Babylon.

The J story (as well as the later P, demonstrably written for the most part in Babylonia) also borrows from characteristically Mesopotamian mythology, particularly the flood story (both J and P versions of the flood legend are preserved in the present Genesis) which goes back to Sumerian times (third millenium BC) in Mesopotamia. (51)

Nothing in the Genesis myth explicitly identifies the story of Adam with the movement around Jehu; a propagandist writing a purported history of primordial sin to promote the unpopular policies of a current rule would naturally seek to avoid references in his document which indicate he is doing just that. But in addition to Eissfeldt's observation of the relation between the Rechabites and the anti-agricultural outlook of the Adam story, the following considerations support the conclusion that there is a direct connection:

First, Jehu is clearly responsible for literarypropaganda activity. In II Kings 9:25, for example, the Bible gives him virtual personal credit for creating the slander against Ahab regarding the acquisition of Naboth's field.

Second, the fact that the Rechabites persist as a nodal point of Mesopotamian influence in Israel down to the time of Jeremiah, a certified Babylonian hireling.

Third, the fact that the various documents contained in the Pentateuch were all preserved by the pro-Babylonian (later Persian) party around Jeremiah et al., pointing to at least a presumption of a continuous factional heritage in their composition.

# V. Israel and Revival in


### Phoenicia and Ionia

Seven years after Jehu's coup d'état, the half-Phoenician Queen Athaliah was overthrown by a similar intrigue in Jerusalem (c. 837). The two kingdoms lived miserably under an anti-Phoenician

regimen for some forty years. Worse for them, for a time after the death of Shalmaneser III (824 BC) Assyrian military power deteriorated rapidly, leaving the two pro-Assyrian states fair game for their more commercially oriented old enemies in Damascus, who remained Assyria's implacable enemies. "In those days," the Bible reports, "Yahweh began to cut off parts of Israel. Hazael (king of Damascus — PA) defeated them throughout the territory of Israel." In Judah, the Syrians were kept at bay only by payment of a heavy tribute. (52)

In approximately 814 BC, however, developments occurred in Phoenicia whose impact soon drew Israel and Judah out of their misery. Pygmalion, the youthful king of Tyre, quarreled with his sister Elissa (Dido), in what was recorded as an attempt to seize the wealth of her husband Acerbas, a rich priest of Tyrian Herakles (Melcarth). The upshot of the struggle was that Elissa and a group of leading Phoenicians from Tyre and Cyprus fled to North Africa where they founded the city of Carthage. (53) Whatever the real differences that underlay the dis-

pute between the two factions of Tyre, Carthage, the "new city," rapidly assumed the leading role in the western end of a major Phoenician trading push west into the Mediterranean which took the Phoenicians to Spain, North Africa, Italy, Sicily, and the Aegean region.

It was the Phoenician revival of this period that inspired Homer, and prompted other Greeks, led by the Ionians and the Dorian Corinthians to found some two score of colonies themselves between approximately 750 and 600 BC. (54) These colonies ranged from the Black Sea area where the Ionian city of Miletus was paramount, to Italy and Sicily where Corinthian networks were the major links with mainland Hellas and points further east, and included Marseilles (Greek Massalia) and the port of Naucratis, established as a joint venture of several Greek trading cities, in Egypt.

This great commercial movement, which produced a sharp increase in trade between the Levant and Egypt, (55) did not pass Palestine by untouched. Its impact was being fully felt in Israel by the reign of

Jeroboam II (c. 786-746), the great-grandson of Jehu who completely reversed his ancestor's policies, once again emphasizing trade, commercial activity, and contact with the Phoenicians. Collaborating in his enterprises was King Azariah of Judah, who rebuilt the port of Elath on the Red Sea coast to facilitate southern trade. (56)

#### The Prophets Respond

The turn in policy in Israel and Judah drew a violent response from the supporters of the Jehuite antiprogress policies, who continued their pro-Assyrian orientation and opposition to commercial development. This is the policy which forms the actual content of the genuine oracles of Amos, Hosea, Isaiah, and Micah, whose fulminations against Jeroboam and on behalf of the Assyrians are the earliest prophetic utterances in the Bible definitely assignable to identified prophets.

The earliest of these prophets is Amos, whose activity is roughly datable to the period 760-750 BC. Amos identifies himself as a simple shepherd of Tekoa, a town not far south of Jerusalem, but his writing is closely connected with that of Isaiah, a member of the pro-Assyrian faction around the Jerusalem royal house and priesthood. It is these circles, and not the poor shepherds of Tekoa, that provided the "inspiration" for Amos's denunciations of wealth and progress, and, presumably, the money to finance the publication and preservation of his utterances.

The activity of the historical Isaiah is datable slightly later, from the year of the death of King Uzziah (Azariah), 746 BC, down to the reign of Hezekiah (c. 715-687 BC). Micah was a contemporary of Isaiah, while Hosea, a bizarre personality who apparently married an adultress to symbolize what he considered Israel's foresaking of Yahweh, was a native of the northern kingdom whose activity occurred roughly during 750-730 BC.

Amos's ministry occurred for a period estimated at perhaps not more than several months, sometime around 760 BC. (57) He left his home in Judah and went to Israel to disrupt services at one of the chief national sanctuaries, Bethel, where he denounced the Israelite merchants for the wealth they were accumu-

lating and called for the assassination of King Jeroboam. He proclaimed:

"Therefore because you trample upon the poor

and take from him exactions of wheat, you have built houses of hewn stone."

Dressed stone houses were a major advance in those days. In Mesopotamia, lacking in stone, most houses were of (water-soluble) mud brick.

High living standards and culture also drew Amos's censure:

"Woe to those who lie upon beds

of ivory,

and stretch themselves upon their couches,

and eat lambs from the flock,

and calves from the midst of the stall;

who sing idle songs to the sound of

the harp." (58)

Officials at Bethel appear to have dealt promptly with the unwanted disrupter:

Then Amaziah the priest of Bethel sent to Jeroboam king of Israel, saying, "Amos has conspired against you in the midst of the house of Israel; the land is not able to bear all his words. For thus Amos has said,

'Jeroboam shall die by the sword,

and Israel must go into exile away

from his land.' "

And Amaziah said to Amos, "O seer, go, flee away to the land of Judah, and eat bread there, and prophesy there; but never again prophesy at Bethel, for it is the king's sanctuary and it is a temple of the kingdom." (59)

If the trend toward progress had continued uninterrupted in Israel and Judah, the career of Amos's cofactioneers would probably have suffered similar ignominious ends, and no utterances of Amos, Isaiah, Hosea, or Micah would have survived to edify succeeding generations.

In 745-744 BC, however, a new Assyrian king, a general who took the royal name Tiglath-pileser (III), seized power, and then promptly contrived to have himself named king of Akkad (Babylon) as well, under the royal name Pul. With this power base, he revived the moribund Assyrian military machine and began a series of military campaigns in Syria, Phoenicia, and Palestine that lasted virtually uninterrupted until his death in 727 BC.

The political fortunes and posterity of Isaiah and Co. were saved. The Assyrian invasions produced political turmoil in Israel, and a rapid turnover of kings.

Whitewashing Tiglath-pileser, Hosea blamed Israel's troubles on its tradition of independent monarchy dating back to Saul (60) and on the existence of the monarchy and its rising wealth:

Israel is a luxuriant vine that yields its fruit.

The more his fruit increased the more altars he built;

as his country improved he improved his pillars (pillars were used in Canaanite ritual — PA).

Their heart is false; now they must bear their guilt. (61)

In 735 BC, an anti-Assyrian king, Pekah, seized power in Israel, and formed a league with Damascus against Tiglath-pileser. The two kings attempted to persuade King Ahaz of Judah — the grandson of Azariah — to join them. In a meeting with Ahaz, Isaiah urged the king to ally instead with Assyria:

"Yahweh will bring upon you and upon your people and upon your father's house such days as have not come since the day that Ephraim (i.e. Israel — PA) departed from Judah — the king of Assyria." (62)

In other words, Isaiah was arguing that Tiglathpileser would actually restore the full extent of the kingdom of David! Anticipating the loot to be gotten in the coming war, the prophet named his newly born son "The spoil speeds, the booty hastes."

Ahaz was convinced. He

sent messengers to Tiglath-pileser, king of Assyria saying, "I am your servant and your son. Come up, and rescue me from the hand of the king of Syria and from the hand of the king of Israel, who are attacking me." Ahaz also took the silver and gold that was found in the house (temple — PA) of Yahweh and in the treasures of the king's house, and sent a present to the king of Assyria. And the king of Assyria hearkened to him. (63)

In 732 BC, Tiglath-pileser conquered and destroyed Damascus, and toppled Pekah from power in Israel. Isaiah's career now took a surprising turn for a man

with his subsequent reputation for devotion to Yahweh. King Ahaz went to Damascus to pay obeisance to Tiglath-pileser, and saw there an altar that the Assyrian king had erected. Ahaz immediately sent back a model of the altar to a crony of Isaiah, Uriah the priest, for duplication in his own temple. Without a peep from the pious prophet, who may be assumed to have supported the deed, the sacred altar of Yahweh was shunted off into a corner to be preserved for use in

In 722 BC, the Assyrians — under a new king, Sargon II — completed the destruction of Samaria, the Israelite capital, carrying off its inhabitants into exile in Syria, Assyria, and Media — the so-called "lost ten tribes." With this, the Assyrian conquest of Israel and Judah was essentially complete, although a rebellion by Ahaz's successor Hezekiah apparently caused Isaiah a little unease.

divination, and the new one, built to Assyrian speci-

fications, installed in its place. (64)

The Phoenician cities of the coast — aided by Ionians — continued to resist the Assyrians until about 701 BC, when the Assyrian king Sennacherib forced their great king Elulaeus to flee to Cyprus. From that time Assyrian domination in the region was not seriously challenged until after the death of the Assyrian king Ashurbanipal in c. 629 BC.


It would be interesting to know what Isaiah's Israelite and Judean opponents — who also worshipped Yahweh — thought of him, and what they had to say about his oracles. Some must have been actively involved in the Phoenician and Greek trading activity, but only Isaiah's side of the story has survived.

Extravagant claims have been made for the significance of Isaiah, Hosea, and Amos's utterances, that these prophets developed the seed of later Christianity and Judaism by attacking sacrifice and idolatry and demanding righteousness and justice as the measuring rod of piety. Nothing is further from the truth.

They were opposed *not* to sacrifice but, in keeping with the spirit of the earlier policy of Jehu, only to Canaanite-Phoenician rituals, which many lessdogmatic Yahweh-worshippers happily practiced. Other than that, as the episode with Tiglath-pileser's altar shows, they were highly flexible on particulars of worship, and certainly practiced sacrifices according to' their own (and Tiglath-pileser's) prescribed rituals.

Their concept was not of a universal god but of a local, Judeocentric sect, which preached that Israel and Judah should be kept isolated from global developments and poor and underdeveloped. For obvious reasons, the Assyrians openly promoted this "religion," and were so supportive of this brand of "Yahwism" that after they deported the "ten tribes" of Israel, they sent back a priest of Yahweh to teach the ways and the "fear" of the "local" Israelite god to the Babylonian and other settlers whom they had settled in Israel in the Israelites' place. (65) And the Assyrians were so confident of "Yahweh's" support in return that when their army arrived before Jerusalem in 701 BC to end Hezekiah's rebellion, its general taunted Hezekiah's officers in Hebrew that he had no support for his revolt, and added:

"Moreover, is it without Yahweh that I have come up against this place to destroy it? Yahweh said to me, Go up against this land, and destroy it." (66)

This is not to say that the Canaanite ritual practices attacked by Amos et al. were good. The fact is that little\_in any of the organized religions of the first millenium BC that have now perished, is a loss to subsequent posterity.

The point is merely that the transformation of the frequently morally reprehensible rites of the time was not the work of the priests and prophets of Yahweh or any other god, but of the numerically tiny group of thinkers and organizers who developed and carried forward the traditions of rationalistic, Ionian science and epistemology.

## VI. Traitor Jeremiah and Deuteronomy

Among the Jerusalem priests, the period from roughly 700 to 625 BC — the period of unchallenged Assyrian hegemony — was spent mostly in importing a plentiful stock of Mesopotamian divinities into Yahweh's temple in Jerusalem. These were identified with the stars — the "host of heaven" — widely worshipped in Babylonia, and included the sun god Shamash, to whom a chariot was dedicated in the temple, and who possessed an altar on its roof. (67)

All this was later blamed on the unfortunate king Manasseh, who happened to rule at this time, but there is no evidence of opposition at the time to this policy by the Jerusalem priests.

By the mid-seventh century, however, the supply of loot available from Assyria's victims began to dry up. It was insufficient, at any rate, to satisfy both Assyria and Babylon, and the two partners grew increasingly at odds.

By 627 BC, shortly after the death of the Assyrian king Ashurbanipal, Babylon became independent under a Chaldean dynasty headed by Nabopolassar, father of the famous Nebuchadnezzar, and was at war with the Assyrians.

In approximately 626 BC, Assyrian control over Palestine and Phoenicia was effectively ended as a result of a raid by a large party of Cimmerians, one of the barbarian hordes that occupied the Black Sea area.

The situation posed a crisis for the Judean faction represented by the Jerusalem priesthood. Their country had been sucked dry by the Assyrians, with whom they had been allied and upon whom they had relied to maintain their power. This prop was gone. They could turn to Babylon — then aiming to take Assyria's place as the dominant power in the area and in fact soon did — but until after 612 BC the Babylonians were preoccupied with the final struggles to wipe out the remaining Assyrian forces, and could be relied on for little more than moral support.

Moreover, a century of Ionian and Phoenician organizing in the Mediterranean area was beginning to pay off handsomely for the Jerusalem priests' commerce-oriented enemies. In a major coup, Ionians and Phoenicians — with aid from Gyges of Lydia, the major kingdom of Asia Minor — had seized effective political control over the Twenty-sixth Dynasty of Saite pharaohs in Egypt. This dynasty, ironically, had originally come to power as vassals of Assyria, but by the late seventh century BC Egyptian trade was channeled through such Greek trading colonies in Egypt as Naucratis, Greek mercenaries formed the backbone of the Egyptian army, and Assyrian influence had vanished.

The Jerusalem temple faction resorted to a desperate stratagem. In 621 BC, in the reign of their puppet-king Josiah, a supposedly long-lost and forgotten law of "Moses" was "discovered" in the temple in Jerusalem. (68) By comparing the account of the discovery in II Kings with the legal codes of the Pentateuch, it has been determined with absolute certainty that this "law of Moses" consisted of the major part of what is today the Book of Deuteronomy.

Originally, the purpose of Deuteronomy was to provide the pro-Babylonian faction — those named include a priest Hilkiah, a prophetess named Huldah, and others (no doubt among them a young prophet named Jeremiah, a fervid supporter of Deuteronomy whose "calling" to the ministry of Yahweh occurred in 626 BC and whose writing style is closely related to Deuteronomy) — with a pretext to militarily crush all potential and-or actual political opposition, and at the same time to grab for themselves every possible loose shekel of revenue in the impoverished kingdom.

The pretext was that "Moses," in the "newly discovered" law, had enjoined that sacrifice — the heart of religious worship — could only be performed at the Jerusalem temple, and that all tithes were payable only to this temple as well. (69) This meant that the multiplicity of local cults and parishes, which had supported themselves and their priests for centuries through their own tithes and were the focus of local, grass-roots political organization, were immediately outlawed.

That the Phoneician-linked, trade-oriented segment of the Israelite-Judean population was especially viewed as a target of this coup is clear from "Moses's" repeated injunctions in Deuteronomy to enslave and exterminate the "Canaanites," and his insistence that the Israelites are a "chosen people" who must steer clear of foreigners and outsiders. (70)

Before anyone had time to question the authenticity of the document, Josiah's troops were sent out in a series of bloody raids against regional places of worship, destroying them' and sometimes slaughtering their priests. (71) To give the required nationalist tinge to the effort to mobilize forces against the "Canaanites," the new law commanded the expulsion of the Mesopotamian gods in the temple — now politically useless anyway. "Yahweh is our god, Yahweh alone," Deuteronomy proclaimed. (72)

In a seesaw battle for control of Palestine and Syria between the Egypto-Greek-Phoenician forces and the Babylonians, the Deuteronomists' own day of reckoning came in 609 BC. The final struggles between Babylon and Persia were waged through a kind of surrogate warfare: the Babylonians had organized neighboring, semi-civilized tribesmen, the Medes, into a quasi-empire whose goal was to destroy the Assyrian cities. Assyrian efforts to enlist the barbarian Cimmerians as a counterforce proved unsuccessful, and the Mede hordes destroyed the Assyrian capital of Nineveh in 614 and Ashur, their mother city, itself in 612.

The year 609 found the remnant of the Assyrian army in the city of Hamath, in Syria, awaiting the final onslaught of the Medes. Since it was now very much in the interest of Egypt, Phoenicia, and the Ionians to prop up the remaining Assyrians against the growing power of Nabopolassar and his Median stooges, an Egyptian army including Milesian mercenaries was sent to Syria under the personal command of the Pharaoh Necho to aid the Assyrians. (73)

Josiah, allied with the Babylonians, led his army out to intercept Necho, and Necho crushed Josiah's forces and killed the king in battle at Megiddo. While the Medes annihilated the remaining Assyrians, they then withdrew, leaving the Greco-Egyptian forces for the time master of Syria and Palestine. In gratitude to his Greek allies, Necho dedicated his arms of victory to the god Apollo at Miletus (74) (where young Thales, of half-Phoenician parentage, was then reaching adulthood), and installed Jehoiachim, a new king more to his liking, in Jerusalem. (75)

Leadership of the Deuteronomic party passed to Jeremiah, of a priestly family from Anathoth north of Jerusalem. Jeremiah was well liked by the Babylonians, whom he served loyally, and equally hated by the Judeans. Even his own relatives and neighbors from Anathoth, whose altar had presumably been one of those shut down by Jeremiah's Deuteronomic law, accused him of being a false prophet and conspired to kill him, warning:

"Do not prophesy in the name of Yahweh, or you will die by our hand." (76)

A chronological summary gives the flavor of his activities:

609 BC: At the beginning of the reign of Jehoiachim, Jeremiah stands in the court of the temple and proclaims that unless the Deuteronomic law (presumably junked upon the death of Josiah or possibly even earlier, although the Old Testament is silent on this touchy subject) is restored, Yahweh "will make this city a curse for all the nations of the earth." (77)

Angered, the priests, prophets, and people demand his execution on the spot, but, through the intervention of officials linked to the Deuteronomic party, he is saved, although banned from the temple. (78)Jeremiah continues his attacks on Jehoiachim, singling out the king for remodeling his palace with Lebanese cedar. (79)

605 BC: Nebuchadnezzar's army routs the Greeks and Egyptians at Carchemish in Syria. Jeremiah seizes on the renewed Babylonian activity to publish a book which declared

that the king of Babylon will certainly come and destroy this land, and will cut off from it man and beast. (80)

The book is read aloud in the temple by Jeremiah's secretary Baruch. With the Babylonian army loose in Palestine, the priests become less antagonistic to Jeremiah's point of view, and they advise Jeremiah and Baruch to hide while they present the book to the king.

Less fearful of the Babylonians than his priests and officials, Jehoiachim slices up Jeremiah's book and burns it piece by piece as it is read to him. He gives orders for the traitor's arrest, but Jeremiah escapes.

601-597 BC: Jehoiachim is forced to pay tribute to the Babylonians in 602-1 BC, but rebels in 598. Jeremiah organizes a fifth column in Jerusalem, including the remnants of the Rechabites sect. (81)

The rebellion is defeated in 597, shortly after the death of Jehoiachim. Nebuchadnezzar carries off Jehoiachim's son and successor, Jehoiachin (also known as Jeconiah), into exile in Babylon, and makes his uncle king, under the regnal name Zedekiah. The Babylonian king also carries off the cream of Judah's skilled craftsmen, as well as a number of priests and nobles, a total of 3,023 captives, according to the book of Jeremiah, among them the future prophet Ezekiel.

597-586 BC: The decade of Zedekiah's reign is a period of bitter struggle between the Babylonians on

the one hand and the progressive tendency represented by the Phoenicians, Ionian Greeks, and their Egyptian allies on the other.

To emphasize the nature of the Ionian contribution to this struggle, it should be noted that it was in the year 594 BC that Solon of Athens introduced his celebrated legal code, which was based not only on a debt moratorium but on establishment of a new, silver-based currency which aimed (largely successfully) at thrusting Athens into a leadership role in commerce in both the eastern and western Mediterranean. (82) Solon was allied in his efforts with the governments of the leading trade-oriented Greek cities, most significantly Corinth and Miletus.

These Greek leaders had to be concerned with commercial developments in the East, and that they were is attested by a Babylonian document from Nebuchadnezzar's reign accusing the Ionians of militarily opposing Babylonian plans. (83)

The Babylonians, for their part, had their eye especially on the wealth of Tyre, which shared many trading routes with the Greeks, particularly those linked to Egypt. The Babylonians' envy and greed for Tyre was memorably expressed in the celebrated denunciation of the Phoenician city — enumerating down to minutiae the details of its wealth — composed by Nebuchadnezzar-agent Ezekiel in the course of Nebuchadnezzar's thirteen-year siege of the Phoenician city, and preserved in chapters 26 to 28 of the Old Testament book bearing Ezekiel's name.

Palestine, in the middle of the battle between the two tendencies, saw competition for the allegiance of the Judeans not only in Judah but in Babylonia as well, where exiled Judeans took part in at least one revolt against Nebuchadnezzar. It is the pressures exerted by the various factions which accounts for the vacillating policies pursued by the unfortunate Zedekiah.

In 594-3 BC, envoys from Sidon, Tyre, Edom, Moab, and Ammon sent envoys to Jerusalem to try to persuade Zedekiah to rebel. This coincided, according to the Chaldean Chronicle, with a rebellion in Babylon itself. Members of the Judean exilic community were drawn into the rebellion, and dispatched letters to Jerusalem demanding that Jeremiah be arrested for urging them to regard their exile as permanent. (84)

Jeremiah met the challenge by (literally) placing a pair of yoke bars on his back, to symbolize subservience to Babylon, and telling the king:

"Do not listen to the words of the prophets who are saying to you, 'You shall not serve the king of Babylon,' for it is a lie which they are prophesying to you. . . . Serve the king of Babylon and live. Why should this city become a desolation?" (85)

In this year, Judah did not revolt, but there was sufficient unrest among the exilic community that the following year Ezekiel received his "call" to curb the "rebelliousness" of the people of Israel.

Jeremiah, meanwhile, sent letters to Babylon informing on those exiles who had attempted to foment revolt in Judah, so that they could be burned alive by the Babylonians as an example. (86)

In 588 BC, however, the Phoenician-linked faction raised another rebellion, backed this time by a sortie by the Egyptian army. The Babylonians besieged Jerusalem, and Jeremiah and Ezekiel worked strenuously to aid them. The overwhelming anti-Babylonian sentiment forced the equivocal king to imprison Jeremiah on charges of treason, (87) but, as the Judeans' military fortuned declined, he met secretly with Jeremiah to discuss possible surrender. (88)

In Babylonia, meanwhile, "Yahweh" commanded Ezekiel, "And you shall set your face toward the siege of Jerusalem, with you arm bared; and you shall prophesy against the city." (89)

In 586, Nebuchadnezzar took and sacked Jerusalem, destroying the city wall, the palace, and Solomon's temple. The leading Judean priests and nobles and the sons of Zedekiah were executed before the Babylonian king at Riblah in Syria. (90) Zedekiah was merely blinded, presumably leniency for his secret negotiations with Jeremiah.

In notable contrast, Nebuchadnezzar gave personal orders to his officers that Jeremiah be protected and furnished a pension. (91)



Following the capture of Jerusalem, Nebuchadnezzar began a bitter, thirteen-year siege of Tyre that ended with the final loss of that city's political independence, and the consolidation of Babylonian rule over Syria and Palestine.

# VII. Babylonian Exile and New Works of Moses

The Judeans' Babylonian exile marked a watershed in the development of Israel's holy books and the political tendency which wrote them, but this tendency was hardly, as is often claimed, engaged in a struggle to preserve Israel's "national" traditions in the midst of the sin and depravity of Babylon.

The Judeans, it is true, did have their own cultural and religious traditions, which can be dimly discerned through the falsifications and distortions of the Deuteronomic history Judges-Kings. These traditions he tapped the resources of the divine prescience. Samuel 23:9ff. recounts:

David knew that Saul was plotting evil against him; and he said to Abiathar the priest, "Bring the ephod here." Then said David, "O Yahweh, the God of Israel, thy servant has surely heard that Saul seeks to come to Keilah, to destroy the city on my account. Will the men of Keilah surrender me into his hand? O Yahweh, the God of Israel, I beseech thee, tell thy servant." And Yahweh said, "He will come down." Then said David, "Will the men of Keilah surrender me and my men into the hand of Saul?" And Yahweh said, "They will surrender you."

As we saw, Yahweh retained this oracular attribute as late as the period of the historical Isaiah, and probably later.

Nor were idols unknown in preexilic Judean history; from the teraphim (household idols) which Jacob and Rachel stole from Laban (they were prohibited by the Deuteronomic Code), to the two golden calves erected at Dan and Bethel by the Israelite king Jeroboam I, to the cherubim which guarded the very altar of Yahweh in the temple of Solomon, the idols and iconography common to the ancient Near East were equally the property of the Judeans and Israelites.

There is no question of the preexilic Old Testament authors groping toward (much less originating) the process-conception of God expressed by Spinoza's concept of extended being or the Christian Neoplatonists' concept of the Logos. The Yahweh of the Old Testament was fully anthropomorphic, complete with an entourage of winged genii, and the prohibition on representations of his image was due not to a desire for abstraction, but rather to a primitive belief that Yahweh's image was *taboo*, and the human being who looked upon it *profane*. Writing as late as the middle of the eighth century, that is at the same time as hubristic Greeks were molding their conception of Odysseus who repeatedly foils the will of the Olympian gods, Isaiah could commit to the scroll such superstitious drivel, regarding his vision of Yahweh (Isaiah 6:1ff.), as:

In the year that King Uzziah died, I say the Lord sitting upon a throne, high and lifted up; and his train filled the temple. Above him stood the

did not differ qualitatively from those of the Israelites and Judeans' neighbors. At an early date, for example, the god Yahweh was regarded as having strong oracular powers. David, among others, carried with him an "ephod" (possibly a deliberate textual corruption for an original "ark," made in deference to the late "ark of the covenant" hoax), through which seraphim; each had six wings; with two he covered his face, and with two he covered his feet, and with two he flew. And one called to another and said:

"Holy, holy, holy is Yahweh of hosts; the whole earth is full of his glory." And the foundations of the thresholds shook at the voice of him who called, and the house was filled with smoke. And I said: "Woe is me! For I am lost; for I am a man of unclean lips, and I dwell in the midst of a people of unclean lips; for my eyes have seen the King, Yahweh of hosts!" Then flew one of the seraphim to me, having in his hand a burning coal which he had taken with tongs from the altar. And he touched my mouth, and said: "Behold, this has touched your lips; your guilt is taken away, and your sin is forgiven."

Nor, apart from the Deuteronomic cult, were most Israelites and Judeans monotheistic, or, more accurately, henotheistic, for even Deuteronomy recognizes the existence of other gods, and, dogmatically, merely forbids their worship. Apart from that, few Judeans, even those who acknowledged Yahweh as their nation's god (as Ashur was for the polytheistic Assyrians and Chemosh for the Moabites), thought to deny other gods their due. Ahab for example, who erected a temple of Tyrian Baal in Samaria, gave his children names compounded from Yahweh. Particularly self-serving is I Kings's claim that Solomon's adoption of foreign cults was due to the bad influence of his foreign wives; the Deuteronomic historian is doctoring history to make his cult's prohibitions against foreign marriages and foreign gods reinforce each other. The reality is that the foreign cults were there all along.

The so-called Song of Moses in Deuteronomy, for example, presupposes a theology in which Yahweh is a subordinate member of the Canaanite pantheon, receiving his allotted domain from its head El, or 'Elyon, "the Most High":

Religion was a political question in the ancient world, as it is today, and the reason that the majority of Judeans opposed the Deuteronomists' henotheism was because the "foreign" gods represented ties to foreign merchants and the trade that accompanied them, and because the Deuteronomists' "Yahwehalone" dogma was openly propagated as pro-Babylonian. This is particularly clear in the reply of

the Judean exiles in Egypt, who had fled there after Nebuchadnezzar's annexation of Judah, to Jeremiah Jeremiah had commanded them (Jeremiah 42:9ff.):

"Thus says Yahweh, the God of Israel, to whom you sent me to present your supplication before him: If you will remain in this land, then I will build you up and not pluck you up; for I repent of the evil which I did to you. Do not fear the king of Babylon, of whom you are afraid."

The exiles in Egypt replied (Jeremiah 44:16ff.):

"As for the word which you have spoken to us in the name of Yahweh, we will not listen to you. But we will do everything that we have vowed, burn incense to the queen of heaven and pour out libations to her, as we did, both we and our fathers, our kings and our princes, in the cities of Judah and in the streets of Jerusalem; for then we had plenty of food, and prospered, and saw no evil. But since we left off burning incense to the queen of heaven and pouring out libations to her, we have lacked everything and have been consumed by the sword and by famine."

There is little of significance for later humanist philosophy and theology in either Jeremiah's hokedup "prophecy," or in the pragmatic views held in opposition by the Judean patriots. In Corinth, as a matter of fact, the popularity of the temple of Aphrodite (as the Phoenician goddess as known in Greek) among sailors was due to the fact that it functioned mainly as a brothel, which had international notoreity. The point is that the Deuteronomists were hardly concerned to preserve Judah's old religious and cultural traditions in the midst of the Babylonian exile. Rather, the Babylonians used them to create entirely new ones, corresponding to the Babylonians' principles of administration of their subject peoples.

Like the Roman and British empires after it, Nebuchadnezzar's Babylon pursued a policy of "local control" and "cultural relativism" in the administration of its subjects. As a matter of policy, the various ethnic groups of craftsmen, etc., carried off by the Babylonians were settled by themselves under a Babylonian-sponsored ruler of their own origins. Greeks, for example, who were resettled by the Persians (who merely continued Babylonian policy in this respect) in the fifth century, preserved their local Greek customs for more than a century in the middle of Iran, where Alexander the Great found them during his conquest of Persia in the fourth century BC. (93)

Accordingly, besides drumming up support for Nebuchadnezzar's foreign policy (Ezekiel), the Babylonians' exilic Judean employees were assigned to mold an appropriate new "ethnic identity" for the Judeans, whose cultural and commercial ties to the Phoenicians were too close for the Babylonians' comfort.

Their creative efforts were stimulated by payments and subsidies from the Babylonian royal fisc. II Kings concludes with the note that "Evilmerodach king of Babylon (reigned 562-560 BC — PA), in the year that he began to reign, graciously freed Jehoiachin, king of Judah from prison; and he spoke kindly to him, and gave him a seat above the seats of the kings who were with him in Babylon. So Jehoiachin put off his prison garments. And every day of his life he dined regularly at the king's table; and for his allowance, a regular allowance was given him by the King, every day a portion, as long as he lived." (94) Administrative documents from the reign of Nebuchadnezzar record payments both to Jehoiachin and his sons, as well as to an unnamed "eight men from Judah." (95) The exilic editor of II Kings being so well acquainted with such payments, it is not hard to imagine that he may have been one of those anonymous eight.

The Deuteronomistic works were their starting point. The Deuteronomists had, besides their lawbook with its emphasis on Israelite exclusivity, an edition of the history Judges-Kings (originally perhaps written before the untimely death of Josiah, to gauge from the unfulfilled prophesy of his peaceful death in II Kings 22:20), written with the purpose of showing that obedience to the Deuteronomic law was the path to peace and happiness on earth, and disobedience would lead to the opposite. They also had collections of prophetic oracles, notably those of Amos, Isaiah, et al., and a combined JE version of Israel's origins (in Babylonia) under the patriarchs and Moses, perhaps already combined with the Deuteronomic legal document.

Where Deuteronomy had concentrated on Yahweh's gift of the land of Israel to the Israelites as the mark of their uniqueness, emphasis on this — unsuited to the conditions of exile in Babylon — was now replaced with emphasis on the practice of various fetishistic rituals supposedly enjoined by Yahweh himself, to form the basis of the special "Judean" identity.

As the German biblical scholar Julius Wellhausen described the process:

Circumcision had been in use before without any particular religious stress having been placed on it; it was not commanded in any law. Now it became, next to the sabbath, of the greatest possible importance as a symbol of Jewishness. Similarly, other old usages were also practiced more assiduously than before, because they could serve for the deepening of Jewish specialness and the seclusion against heathendom. Through this the priests who had been placed out of work by the destruction of the temple found an opportunity to intrude and give

answers out of their Law to questions on what was clean and what unclean, what permitted and what forbidden, in the daily life of every individual. (96)

In addition to this ritualistic cant, the Judean exilic writers were heavily influenced in their doctrines by the chief Babylonian cult, that of Bel Marduk, whose priesthood and temple, the Esagila, was a powerful political force in Babylon. In addition to possessing a creation account which was closely paralleled in the later "Priestly Code" account of Genesis 1-2:4a, the Marduk cult preached the doctrine that man's role on earth is to make life comfortable for the gods, through his services to their priests (who commonly owned large estates and business and banking enterprises).

The Babylonian national epic, the *Enuma Elish* (or "Babylonian Genesis") is quite frank on this account. Marduk declared to the other gods:

Verily, savage-man I will create.

He shall be charged with the service of the gods

That they might be at ease!


The gods build the Esagila in Babylon as a dwelling for Marduk, and proclaim,

- May he (Marduk PA) shepherd the black-headed ones (mankind – PA) his creatures.
- To the end of days, without forgetting, let them acclaim his ways.
- May he establish for his fathers (the other gods PA) the great food-offerings;
- Their support they shall furnish, shall tend their sanctuaries.
- May he cause incense to be smelled, ... their spells,
- Make a likeness on earth of what he has wrought in heaven.
- May he order the black-headed to revere him,
- May the subjects ever bear in mind to speak of their god,
- And may they at his work pay heed to the goddess.
- May food-offerings be borne for their gods and goddesses.

Without fail, let them support their gods! (97)

Adopting this model in their exile, the remnants of the Jerusalem priesthood, the "sons of Zadok," followed up the coup they staged with the Deuteronomic code, by beginning to elevate themselves to the exalted status of the Aaronic high priesthood of the Priestly Code and the later Judean "theocracy."

At the center of their doctrinal reworking was the priest-cum-prophet Ezekiel. In his book there first appears the fetishistic concern with ritual purity which dominates the "Mosaic" laws of the later "Priestly Code," as well as the first efforts to raise the Zadokite priests, the equals of the other Levites in Deuteronomy, above them. And whereas under the monarchy the priests had been in the service of the king, in Ezekiel the Zadokite priests begin to appear as the king's equals — a condition well suited to a government subservient to Babylon.

"Other priests attached themselves to him," Wellhausen concluded, and thus began the work of the

numerous busy hands that, roughly in the century 550 to 450 BC, produced the "Priestly Code" and incorporated it into the modern Pentateuch. (98)

#### The Second Isaiah

Nevertheless, the Babylonian priests and their various stooges did not have a political monopoly in Babylon. The entire Mediterranean world was an arena of political struggle between forces favoring progress, represented, following the Babylonians' capture of Tyre, mainly by the Ionian cities and their ally King Croesus of Lydia, and the sterile reactionaries centered in Mesopotamia. Each side developed its political intelligence networks to subvert the other, the Babylonians having among their foreign hirelings the brother of the Lesbian poet Alcaeus, who fought as a mercenary in Nebuchadnezzar's army, as well as the otherwise unidentified "Zabiria the Lydian" and unnamed Greeks and men of Tyre, Arvad, and Byblos, who are listed in surviving Babylonian financial records as recipients of Babylonian payments.

Among the Ionians, the period following the death of Nebuchadnezzar in 562 BC was the highpoint of the scientific school of the Milesians Thales and the even more powerful thinker Anaximander, one of whose principle areas of activity was the development of geography and cartography to aid in commerce. Another Ionian thinker, Xenophanes of Colophon, began to articulate a systematic concept of a truly universal and abstract deity, ridiculing all notions of anthropomorphism as well as animal and vegetable attributes of deities, etc.

The Near Eastern political networks who were the Ionians' cothinkers are clearly responsible for the original portions of the Book of Job (concluding with chapter 27), a political attack on the Neo-Babylonian status quo in the form of an Arab merchant's dialogue with God. The first twenty-seven chapters of Job consistently prefer the abstract "God" over the proper name "Yahweh" (which appears only once) in referring to the deity, and he has been entirely freed from his narrow fiefdom over the Jerusalem temple which preoccupied the Deuteronomists, and given a more universal scope. (Instead of being suppressed, the Book of Job has been coopted into line with ortho-

doxy by the later addition of chapters 28ff., particularly the crass speeches of Elihu.)

The Ionian networks clearly played their part in the political paralysis which seized Babylon in the period from 562 BC, the death of Nebuchadnezzar, to 538 BC, the occupation of Babylon by Cyrus of Persia — a period which saw such events as a successful strike by stonecutters against a building project sponsored by the king and a wealthy temple, and a marked diminishing of the power of the priests of Marduk which was reflected in the cancellation for some years of their new year's celebration.

The faction around the Marduk priesthood was able to resolve the situation in their favor, however, through the use of the army of Cyrus of Persia. From the point of his seizure of rule over the Median Empire sometime around 550 BC, when it appeared that the former Babylonian stooge Astyages the Mede was going to establish a durable entente with Greek-ally Croesus of Lydia, Cyrus's career had been guided by influential factions in Babylon. (99) In 546 BC, he successfully conquered both Lydia and the Ionian cities of Asia Minor, in what proved to be a fatal blow to Ionian development. In 538 BC, the priests of Marduk resolved their ongoing dispute with the reigning king of Babylon, Nabonidus, by inviting Cyrus to take over the kingship of Babylon himself. As Cyrus relates the story of his "conquest":

Marduk, the great lord, a protector of his people/worshippers, beheld with pleasure his (i.e. Cyrus') good deeds and his upright mind (lit.: heart) (and therefore) ordered him to march against his city Babylon. He made him set out on the road to Babylon going at his side like a real friend. His widespread troops — their number, like that of the water of a river, could not be established — strolled along, their weapons packed away. Without any battle, he made him enter his town Babylon, sparing Babylon any calamity. He delivered into his (i.e. Cyrus') hands Nabonidus, the king who did not worship him (i.e. Marduk). All the inhabitants of Babylon as well as of the entire country of Sumer and Akkad, princes and governors (included), bowed to him (Cyrus) and kissed his feet, jubilant that he (had received) the kingship. . . . (100)

Cyrus also had his supporters in the Judean exilic community, among them the anonymous author of

Isaiah 40-55, the so-called Second Isaiah, who proclaimed, in chorus with the priests of Marduk, that

Thus says Yahweh to his anointed, to Cyrus, whose right hand I have grasped, to subdue nations before him and ungird the loins of kings, to open doors before him that gates may not be closed: "I will go before you and level the mountains, I will break in pieces the doors of bronze and cut asunder the bars of iron, I will give you the treasures of darkness and the hoards in secret places, that you may know that it is I, Yahweh, the God of Israel, who call you by your name. For the sake of my servant Jacob, and Israel my chosen, I call you by your name."

While Cyrus directly acknowledged the support of the powerful Marduk, Yahweh's was merely one of a plethora of less significant but nevertheless loyal cults whose worship he encouraged to assist in the management of his new subjects. The lack of explicit royal recognition of Yahweh did not trouble the politically oriented Second Isaiah. His Yahweh declares to Cyrus:

I surname you, though you do not know me. I am Yahweh. (101)

The Second Isaiah is transparently a counterinsurgent, who betrays very clearly the degree to which opposition to Babylon and the cosmopolitan worldview reflected in Job had penetrated the exilic community. The Second Isaiah pays lip service to both notions, but his conviction is belied by his preoccupation with the establishment of the Deuteronomic cult in Jerusalem:

"I made the earth, and created man upon it; it was my hands that stretched out the heavens, and I commanded all their host. I have aroused him in righteousness (i.e. Cyrus — PA), and I will make straight all his ways; he shall build my city (Jerusalem — PA) and set my exiles free, not for price or reward," says Yahweh of hosts. (102)

The goal of the restoration, this counterinsurgent states, is to institute the Babylon-devised rigamarole of "Mosaic" ritual in Jerusalem, including collection of the profitable tithes, and he makes very clea. that Yahwism as he conceives it in Babylon is not currently practiced in Palestine, where worship has followed a more independent course:

"Yet you did not call upon me, O Jacob;

or satisfied me with the fat of your sacrifices.

But you have burdened me with your sins, You have wearied me with your

inequities."(103)

Put on your beautiful garments, O Jerusalem, the holy city; for there shall no more come into you

the uncircumcised and the unclean.

Depart, depart, go out thence (i.e. from Babylon — PA), touch no unclean thing;

go out from the midst of her, purify yourselves,

you who bear the vessels of Yahweh. (104)

## VIII. Persia, Ezra, and the Torah

From the beginning of Cyrus's reign, the Persian government based its administrative policy — both domestic and foreign — on the principle of "divide and rule," the paradigm being its notorious funding of both Athens and Sparta to war against each other in the period around 400 BC. Domestically, this was expressed in a policy of pluralism and the fostering of both local "self-government" and local cults. An inscription of Darius the Great (I, reigned 522-486 BC), for example, touts the Persian monarch as a great defender of the cult of Apollo of Magnesia on the Maeander (near Miletus) against his own "over-zealous" officials. (105)

The details of this policy as it applied to the Judeans are garbled and sometimes contradictory. The diffi-

culty lies in the fact that both the books of Ezra and Nehemiah, the main sources for the details in question, stem from the at best notoriously unreliable and at worst outright lying hand(s) responsible for the two books of Chronicles. Applying the accounts of events in Kings as a check for the veracity of the corresponding accounts in Chronicles long ago revealed, for example, that the Chronicler freely rewrote those sections of Kings which did not correspond to the dogma of the Priestly Code (which was not in existence when Kings was written). In the cases of the books of Ezra and Nehemiah, the difficulty of determining the accuracy of events is compounded by the fact that no other source exists to cross-check the majority of the Chronicler's claims.

In the one significant case where there is an outside check, the report in the book of Ezra of the return under Cyrus and the rebuilding of the temple, the veracity of the Chronicler's account is impeached by contradictory details in the book of Haggai. Ezra 1 forthrightly reports a decree of Cyrus commanding the rebuilding of the temple in his first year of rule (referring to his accession in Babylon in the year 538 BC). It further claims that funds from the Persian treasury were made available for this purpose. But Haggai 1 states clearly that in the second year of Darius (520,BC), the temple was not only still in ruins, but the local population in and around Jerusalem was not eager to see it reconstructed under the aegis of a group of priests and nobles who had returned from Babylon apparently for that purpose. Once the temple was rebuilt, the book of Ezra claims that it was richly appointed with utensils and other ritual paraphernalia, but Haggai 2:3 describes it as an impoverished and mediocre structure, especially by comparison with the old temple of Solomon.

**OLD TESTAMENT** 

Recording of the oracles of Babylonian

Proceeding in the book of Ezra's account, the list of purported "returnees" under Cyrus reported in chapter 2 is repeated name for name as a census of Judeans living 100 years later in the book of Nehemiah, chapter 7!

Thus, while the books of Haggai and Zachariah confirm that some sort of "return" had occurred before the second year of Darius, the details of this return, as reported by the book of Ezra, cannot be regarded as wholly the truth.

Fortunately, there is a consistent method behind the Chronicler's lying, which makes it possible to restore the essence, if not the details, of the three-quarters of a century separating the Second Isaiah from the return of Ezra the Scribe from Babylon bearing with him the "law" of Yahweh.

The outlook elaborated by the authors of the Priestly Code was perfectly suited to Persian administrative requirements. The Palestine-Syria region, which had been bled under Nebuchadnezzar and was bled again under Darius and Xerxes, was perpetually a hotbed of revolt. It was also well situated to make the outside contacts, particularly with the Greek world and with Carthage, which could make revolt a success. The doctrines expressed by the Babylonian-inspired priestly circles were so "exclusionary" that, for example, when the Samaritans — descendants of settlers placed in Israel by the Assyrians and at that time graciously supplied with priests of "Yahweh" to maintain the continuity of the Yahweh cult in Israel offered to help with the rebuilding of the temple, Haggai successfully protested on the grounds that they were "unclean."

The internal features of the Priestly Code's belief structure required that it be portrayed as having existed among the Judeans — the "chosen people" from time immemorial, from, in fact, the very act of creation by God in the Priestly Code's Genesis which already celebrates the sectarian institution of the sabbath. However, Israelite and Judean history was for the most part a history of opposition to the principal features of the Priestly Code and its lineal predecessors.

Moreover, there is considerable evidence from the prophecies of "Malachi" and the "Third Isaiah," apparently written in the period preceding Ezra's arrival in Jerusalem, as well as from the events of Ezra and Nehemiah's activity, that many Judeans continued to disobey the Deuteronomic and Priestly Codes' strictures right down to the time of the living memory of the Chronicler (who wrote most likely in the fourth century BC towards the end of the Persian period).

For the premonarchic period, there was little to check the imaginations of the Priestly authors as they fabricated their "Mosaic" stories, rituals, and injunctions to supply "traditional" precedents for their own practices (we will demonstrate in examples below), and the Chronicler enjoyed a similar latitude in his inventions apropos of the period of monarchy, which had come to a close in 587 BC, more than 200 years before his time. His source, the two books of Kings, was rare, and in any case Hebrew, the language of Kings, was being replaced by Aramaic as the language of most Judeans. The two books of Chronicles essentially rewrite Kings to make it appear that the Priestly Code was already in existence in the monarchic period. With respect to the Persian period itself, however, the Chronicler was approaching events within or close to living memory of his contemporaries. Rather than risk being caught in too blatant a forgery, the Chronicler appears simply to have omitted or obscured major events which tended to expose the real unpopularity of his cause, while exaggerating or embellishing others, for instance the amount of financial help the Persians contributed to the rebuilding of the temple, which were appropriate to his purpose. Consequently, there are substantial gaps in the books of Ezra and Nehemiah's account of the events of the sixth and fifth centuries BC, and details, as noted above, which are demonstrably spurious. But the basic outline of the remaining events seems accurate.

In this outline, there is a gap of some sixty years, between the year 519, when the book of Zechariah indicates that a member of the Davidide line, Zerubbabel ("Offspring of Babylon") was involved in an unsuccessful revolt against Darius, (106) and Ezra's arrival in Jerusalem in the year 458 BC, for which neither the Chronicler nor any other source furnishes historical information on events in Judah. It is clear that some of the priestly institutions being evolved in Babylon, such as the institution of the high priesthood, were in effect in Jerusalem and that others, particularly the injunction against foreign marriages commanded by both the Priestly and older Deuteronomic Codes, were not. Wellhausen's assessment of the situation was that "the priests who had stayed in Babylon took as great a part, from a distance, in the sacred services, as their brothers at Jerusalem who had actually to conduct them. The latter indeed lived in adverse circumstances and do not appear to have conformed with great strictness or accuracy to the observances which had been agreed upon." (107) The pro-Babylonian "Malachi" complains: "Judah has been faithless, and abomination has been committed in Israel and in Jerusalem; for Judah has profaned the sanctuary of Yahweh, which he loves, and has married the daughter of a foreign god." (108)

These sixty years of missing history were eventful for the Persian Empire. Upon gaining the throne, Darius commenced upon a reorganization of the

ordered their Judean stooges to revolt, as Zechariah 6:10-14 explicitly states. Later, when the Babylonians struck a deal with Darius on favorable terms (as indicated by the fact that Darius later claimed Babylon had remained loyal all along in his notoriously lying Behistun inscription, copies of which were circulated throughout his empire for propaganda purposes), Zerubbabel was apparently left holding the bag, and disappeared from further Judean history.

realm which transformed Persia from a loose confederation of states into a tightly administered region devoted to tax farming and securing a steady flow of loot from the provinces toward the royal treasury at Persepolis and the banks of Babylon. By adopting a conscious policy of restricting the supply of specie, the Persian government forced citizens to turn more and more to moneylenders for the cash required to pay the tax collectors. The result was a sharp jump in prices in the reign of Darius. (109)

Among those burdened with rising debts, inevitably, were the rude Persian nobility themselves. First under Darius, and then under his son Xerxes, they attempted to solve their problem by looting Greece. Both attempts by Darius and Xerxes failed, and when Xerxes's expedition ended in utter rout in 479 BC, the Athenians responded to the situation by organizing the Ionian cities into the Delian League and pursuing an active anti-Persian policy for approximately a quarter century, until the hegemony of Pericles.

The assassination of Xerxes, who had quarreled with the Babylonians in 465 BC, and his replacement by the more pro-Babylonian Artaxerxes I propelled the Persian empire's situation from bad to worse. In 460 BC Egypt revolted with Athenian support. With their forces in control in Egypt, Athenian troops were operating on the Phoenician coast in 459 or 458. (110)

It was in these circumstances that the final denouement of the story of the Pentateuch and "Mosaic" Law occurred. The book of Ezra contains what it describes as a decree of Artaxerxes issued to the Jewish scribe Ezra in 458 BC:

Artaxerxes, king of kings, to Ezra the priest, the scribe of the law of the God of heaven. And now I make a decree that any one of the people of Israel or their priests or Levites in my kingdom, who freely offers to go to Jerusalem, may go with you. For you are sent by the king and his seven counselors to make inquiries about Judah and Jerusalem according to the law of your God, which is in your hand, and also to convey the silver and gold which the king and his counselors have freely offered to the God of Israel whose dwelling is in Jerusalem...

And I, Artaxerxes the king, make a decree to all the treasurers in the province Beyond the River: Whatever Ezra the priest the scribe of the law of the God of heaven, requires of you, be it done with all diligence, up to a hundred talents of silver.... Whatever is commanded by the God of heaven, let it be done in full for the house of the God of heaven, lest his wrath be against the realm of the king and his sons. . . .

And you, Ezra, according to the wisdom of your God which is in your hand, appoint magistrates and judges who may judge all the people in the province Beyond the River, all such as know the laws of your God; and those who do not know them, you shall teach. Whoever will not obey the law of your God and the law of the king, let judgment be strictly executed upon him, whether for death or for banishment or for confiscation of his goods or for imprisonment. (111)

This "law" and "wisdom" of God that Ezra took with him, substantially the modern Pentateuch, was an extraordinary document.

With the inclusion of the Priestly Code to the older J,E, and D documents, the Pentateuch is a program for the erection and functioning of an elaborate, priestocratic organization. Its psychological premise was that the people of Judah, denied their own secular government, could be induced to accept as an illusory substitute, "their own" sacred priestocratic structure. "The state suffered not a crisis, but destruction," Wellhausen wrote. "In earlier times the national state as it had existed under David was the goal of all wishes. Now a universal world empire was erected in imagination, which was to lift up its head at Jerusalem over the ruins of the heathen powers." (112)

In the form in which it presently exists, numerous hands have contributed to its formation. Whether Ezra was the editor who inserted the Priestly Code into the Pentateuch or whether it was an associate or someone before him is irrelevant; on the one hand, there is a tradition that Ezra wrote the Pentateuch, contained in the later "Ezra Apocalypse" (IV Esdras), but on the other hand, Ezra is identified in the book of Ezra only as a "scribe," and in any case there are clear indications of additions to the Pentateuch after the period of his activity.

Some of the institutions of Ezra's law had already been imported from Babylon, such as the high priesthood, but others came as a distinct shock to the Judeans.


For instance the new levels of tithes. Compared to the level of tithes in Israel's earlier days, under the Priestly Code,

and trespass offerings, the greater share of the vegetable offerings, the hides of the burnt offerings, the shoulder and breast of meat offerings. Over and above are the firstlings, to which are added the tithes and first-fruits in a duplicate form, in short, all *kodashim*, which originally were demanded merely as ordinary meat offerings (Deut. 12:26 - ver. 6, 7, and so on), and were consumed at holy places and by consecrated guests indeed, but not by the priest. And notwithstanding all this, the clergy are not even asked (as in Ezekiel is the prince, who there receives the dues, 45:13 seq.) to defray the cost of public worship; for this there is a polltax. . . . (113)

Payments of sin offerings were required, for example, by anyone who "touches an unclean thing" (Lev. 5:2) or "human uncleanliness, of whatever sort" (Lev. 5:3), and by a wollian who has given birth, and is accordingly "unclean" for either seven days, if the child is a boy, or fourteen if it is a girl, according to Lev. 12:2, 5. mixed marriages, all, of course, commanded personally by Moses.

These institutions were a novel and bitter pill for the citizens of Judah. To sweeten them, the Priestly Code introduced some novel new historical "facts," which consoled them that the Priestly Code had really been in effect throughout Israel's earliest history. Regarding the "Mosaic" tabernacle of Exodus, Wellhausen observed:

Until the building of Solomon's temple the unity of worship according to it had, properly speaking, never had any existence.... The Priestly Code, on the other hand, is unable to think of religion without the one sanctuary, and cannot for a moment imagine Israel without it. carrying its actual existence back to the very beginning of the theocracy, and, in accordance with this, completely altering the ancient history. The temple, the focus to which the worship was concentrated, and which in reality was not built until Solomon's time, is by this document regarded as so indispensable, even for the troubled days of the wanderings before the settlement, that it is made portable, and in the form of a tabernacle set up in the very beginning of things. For the truth is, that the tabernacle is the copy, not the prototype, of the temple at

In addition, the Priestly Code revived the old and long-disobeyed Deuteronomic prohibition against

Jerusalem. The resemblance of the two is indeed unmistakable, but it is not said in I Kings 6 that Solomon made use of the old pattern and ordered his Tyrian workmen to follow it. The posteriority of the Mosaic structure comes into clearer light from the two following considerations.... In the first place, in the description of the tabernacle mention is repeatedly made of its south, north, and west side, without any preceding rubric as to a definite and constantly uniform orientation; the latter is tacitly taken for granted, being borrowed from that of the temple, which was a fixed building, and did not change its site. In the second place, the brazen altar is, strictly speaking, described as an altar of wood merely plated with brass, — for a fireplace of very large size, upon which a strong fire continually burns, a perfectly absurd construction, which is only to be accounted for by the wish to make the brazen altar which Solomon cast (II Kings 16:14) transportable, by changing its interior into wood. (114)

Of a similar mold is the Priestly Code's creation story in Genesis 1. The Priestly author has taken the shell of a typical cosmology of the period — the creation story associated with the *Enuma Elish* is often cited as a parallel — and then distributed the (eight) acts of creation over six days, reserving a seventh for God to rest, to impart cosmological significance to the sectarian dogma of the sabbath. Already by Philo's time it was a scandal that the sloppy Priestly author, in copying his prototype, postponed the creation of "lights in the firmament of the heavens to separate the day from the night" until the "fourth" day, leading Philo to question how the duration of the three prior days of creation could have been demarcated without night and day.

The Code was hardly a defense of "monotheism" either. The Priestly creation account itself contains the embarrassing polytheistic formulation "Let us make man in our image, after our likeness" so troublesome to later exegesis, and preserves from an older source the even more awkward story of how "the sons of God saw that the daughters of men were fair; and they took to wife such of them as they chose." (115)

Ezra could hardly have expected a friendly welcome for this concoction, and it appears he did not even attempt to introduce it upon his arrival. In fact, it

looks like Ezra's mission fell on its face. Both Ezra and his later collaborator Nehemiah began their efforts by focusing on the question of mixed marriages, whose dissolution they merely saw as a means to break the politically troublesome Jerusalemite ties to the merchants of Arabia and the Phoenician and Palestinian coast. Not long after his arrival, in 458, Ezra summoned the Judeans to an assembly — in the midst of a rainstorm — and commanded the Judeans to give up their foreign wives. They agreed, but pointed out that "the people are many, and it is a time of heavy rain; we cannot stand in the open. Nor is this a work for one day or for two; for we have greatly transgressed in this matter." The book of Ezra then breaks off with the report that a commission was formed to determine the number of foreign wives and made findings, but it makes no mention of any actual divorces. (116)

The conclusion that this abrupt and informative end of the book indicates failure of Ezra's mission is strengthened by the fact that there is no historical data in the Old Testament which records the events of the next 13 years, and that when the historical thread resumes, in 445 BC, a delegation of Jerusalemites of the Ezraite party has arrived in Susa, Artaxerxes's capital, to plead for assistance from Nehemiah. Nehemiah was a Jew, eunuch, and cupbearer to the king. (117)

Using his influence over Artaxerxes, Nehemiah had himself named governor of Judah, and promptly departed for Jerusalem with a guard of Persian troops. (118)

Again, the political situation in 445-44 BC was precarious for the Persians. Syria had recently revolted, under the leadership of an old Persian crony of the late Xerxes, and while the rebel had been bought off through the intervention of the Persian Queen Mother, the sentiment for revolt was still widespread among the local population which lacked such connections to the royal household.

Nehemiah's tactic was to use his position in Jerusalem to disrupt any possibility for unity of action by the various cities in and around Palestine. He began by rebuilding the Jerusalem fortifications, using contracts on the project to bribe local craftsmen. Since a fortified Jerusalem under Persian official Nehemiah was a *de facto* military threat to the surrounding, less loyal cities, notably Samaria, tensions immediately arose. Nehemiah instituted strict observance of the sabbath and other measures to restrict the activities of foreign merchants in Jerusalem, and organized the

"Levites" as a religious police force to break up marriages with foreigners. (119)

The outcome was a near civil-war situation between the Samaritans and Jerusalem, precisely the overall policy goal of the Persians, who appear to have encouraged both sides in the dispute. Now was the moment for Ezra to publicly unveil his law and impose its complete provisions on the populace. In a great assembly, apparently in 444 BC,

... all the people gathered as one man into the square before the Water Gate; and they told Ezra the scribe to bring the book of the law of Moses which Yahweh-had given to Israel. And Ezra the priest brought the law before the assembly, both men and women and all who could hear with understanding.... And he read from it facing the square before the Water Gate from early morning until midday, ... the Levites helped the people to understand the law, while the people remained in their places. (120)

Evidently the Judeans did not like what they heard, "for all the people wept when they heard the words of the law." In response, Ezra enjoined them, "This day is holy to Yahweh, your God; do not mourn or weep," but the commotion grew beyond arresting, and he was forced to send the crowd home commanding them to celebrate a feast. (121)

The remainder of the month was devoted to further feasts and holy days, as well as special study of Ezra's law by leading Judeans. At the end of the month, a sufficient number of leading Judeans to pass as a representative quorum of the citizenry signed a covenant in Nehemiah's presence pledging that they would pay the tithes demanded by the new law. (122)

Nehemiah's first governorship lasted 12 years, until 433 BC, at which time he departed for Susa. The rebellious forces he had kept in check immediately resurfaced, with his old enemies almost immediately regaining positions of influence in even the Jerusalem temple. Nehemiah returned for a second gubernatorial term, to deal forcibly with the ongoing problem of mixed marriages:

In those days also I saw the Jews who had married women of Ashdod, Ammon, and Moab; and half of their children spoke the language of Ashdod, and they could not speak the language of Judah, but the language of each people. And I contended with them, and cursed them and beat some of them and pulled out their hair; and I

made them take oath in the name of God, saying, "You shall not give your daughters to their sons, or take their daughters for your sons or for yourselves. (123)

Nehemiah was able to win nominal acceptance of the law, ending centuries of purported sin and disobedience by the Israelites which the Bible asserts goes back to the very period of the Exodus. With the law accepted by all — or rammed down their throats — disagreements began to assume the form of interpretation of the law: the Talmud.

The Persians now felt confident enough to proceed to impose this new belief structure on the Jews of Egypt, who since the days of Jeremiah had continued to follow their own, polytheistic brand of Yahwehworship. A decree of the Persian king Darius II dated 419 BC commands the Jews of Elephantine, the old enemies of Jeremiah who had never even accepted the Deuteronomic law, to begin observing the Passover, one of the major points of the Deuteronomic program:

To my brethren Yedoniah and his colleagues the Jewish garrison, your brother Hananiah. The welfare of my brothers may the gods seek at all times. Now, this year, the fifth year of King Darius, word was sent from the king to Arsames (satrap of Egypt) saying, "Authorize a festival of unleavened bread for the Jewish garrison." So do you count fourteen days of the month of Nisan and observe the passover, and from the 15th to the 21st day of Nisan observe the festival of unleavened bread. Be ritually clean and take heed. Do no work on the 15th or the 21st day, nor drink beer, nor eat anything in which there is leaven from the 14th at sundown until the 21st of Nisan. Bring into your closets anything leavened that you may have on hand and seal it up between those dates. By order of King Darius. (124)

For their efforts Ezra and Nehemiah have been recognized, along with King Artaxerxes, as the founders of modern Judaism. But they would not have succeeded without important indirect assistance from the famous Pericles of Athens. In 449 BC, upon assuming power in Athens, Pericles reversed the Delian League's anti-Persian policy and concluded a corrupt treaty with the Persians which recognized Palestine as Persia's "sphere of influence." Cut off from their traditional support from the west, Palestine and Phoenicia were powerless to mount any serious

resistance to Persian policies. Ironically, this same Pericles was also the funder and patron of the indifferentist sophist movement, whose bitterest enemy, Plato, probably had more to do than any other individual in determining the particular form that philosophical Christianity and Judaism later assumed. Ironically, Plato's dialogue with the greatest influence on later Judeo-Christian doctrine, his *Timaeus*, was named for a contemporary of Nehemiah, Timaeus of Italian Lokri.

The certification of the Pentateuch as canonical under the Persians by no means brought an end to the production of Jewish canonical books. Chronicles was written after the Pentateuch, as were many psalms and the present edition of the Psalms as a whole. The present edition of the prophetic books is quite late, and the fact that the Book of Daniel was written around 166 BC, in the reign of the Seleucid monarch Antiochus IV Epiphanes, was already known to the third century AD Neoplatonist Porphyry. (125)

The books of the Hebrew Old Testament were not fixed until about 100 AD, and the Septuagint, the Greek translation of the Old Testament made in the third century BC, differs from it considerably. Nor is the viewpoint of the Mosaic Pentateuch maintained in all its particulars throughout the other books. The book of Ruth, for example, is a clear polemic against the "Mosaic" prohibition against mixed marriages.

The primary invariant in the Jewish faith as articulated by Ezra and Nehemiah is that its most ardent defenders were the foreign governments which ruled the Jews. When Alexander the Great conquered Palestine in the latter part of the fourth century BC, bringing with him a train of Aristotelian philosophers to help him administer his new empire, the Persian policy of supporting the temple was continued. No less than the celebrated Aristotelian Theophrastus pronounced the Jews a "philosophical race," while another Aristotelian Clearchus compared them with the Indian Brahmans and the Persian magi. (126) A probably reliable tradition holds that the Septuagint translation of the Hebrew books was undertaken upon commission of king Ptolemy II, Philadelphus (285-246 BC), a member of the bankrupt Hellenistic dynasty in Egypt then ruling Palestine, and both the Seleucid Greek dynasty in Syria and the Ptolemies sponsored the Jerusalem priesthood to collect tribute and farm taxes. (127)

The Romans later manipulated the "nationalistic" Maccabees to further their own interests against the Seleucids.

By the first century AD, when the Neoplatonic currents that eventually overturned the Hellenistic Roman system and paved the way for the later Islamic developments were active, it was easier for the majority — especially the mass organizers of Christianity — simply to accept the canonical authority of the Old Testament, with the necessary exegetical qualifications.

But in the first century AD, when Paul of Tarsus initiated the form adopted by subsequent Christian doctrine, the Old Testament served a new purpose: it was not politically possible in those days simply to start a new religion on its merits, Christianity had to demonstrate its antiquity and historical traditions. The early Church fathers accordingly pointed to the Old Testament, claiming to find within it certifiably antiquated "prophesies" of the coming of the Christ. At the same time, however, the doctrine of Christ's redemption of man's sin gave Paul et al. all the pretext they needed to discard most of the aspects of Old Testament-enjoined religious practice as no longer necessary. In the second and third centuries AD, when some defensive Christians even resorted to writing fake gospels and epistles in order to establish the historicity of the faith's earlier figures, there was no mood to then discard a religious book such as the Old Testament which even in those days could be shown to antedate Plato. Instead, the Neoplatonists who dominated Christianity followed Philo in accepting the canonical authority of the Old Testament, but reinterpreting it allegorically or passing it off as a "mystery" whose "true" meaning is hidden from all but a few.
